THIS TEST REFLECTS A BROADER SOCIETAL INTEREST IN MEASURING PHYSICAL APPEAL AND OFTEN SERVES AS A FORM OF SOCIAL ENTERTAINMENT OR CURIOSITY.

ORIGINS AND POPULARITY

METHODOLOGIES BEHIND THE TEST

CROWD-SOURCED OPINIONS
