THE BBB EVALUATES HOW PROMPTLY AND EFFECTIVELY A DEALERSHIP RESOLVES ISSUES, WHICH IS CRITICAL FOR MAINTAINING A POSITIVE RATING.

CRITERIA USED IN BBB RATINGS

BBB RATINGS ARE DETERMINED BY EVALUATING VARIOUS CRITERIA SUCH AS COMPLAINT HISTORY, TYPE OF BUSINESS, TIME IN OPERATION, TRANSPARENT BUSINESS PRACTICES, AND LICENSING.
