Based on findings, the healthcare provider determines if the athlete is cleared for participation, requires restrictions, or needs further evaluation. Documentation of clearance is essential for school or sports organizations.

USING THE CORRECT CODE FOR SPORTS PHYSICALS

Most sports physicals are coded using one of the preventive medicine codes listed above, depending on whether the patient is new or established. The sports physical is considered a preventive service rather than a problem-focused visit, so E/M codes like 99201-99205 or 99211-99215 are generally not appropriate unless a separate issue is addressed.

BILLING GUIDELINES AND DOCUMENTATION REQUIREMENTS
