#### SECTION 504 OF THE REHABILITATION ACT

Section 504 prohibits discrimination against individuals with disabilities in programs receiving federal funding. It requires schools to provide accommodations and modifications to ensure equal access to educational opportunities. This law complements IDEA by addressing the needs of students who may not qualify for special education but still require support.

### EVERY STUDENT SUCCEEDS ACT (ESSA)

ESSA INCLUDES PROVISIONS THAT IMPACT SPECIAL EDUCATION BY PROMOTING HIGH ACADEMIC STANDARDS AND ACCOUNTABILITY FOR ALL STUDENTS, INCLUDING THOSE WITH DISABILITIES. IT ENCOURAGES THE INTEGRATION OF SPECIAL EDUCATION STUDENTS INTO STATE ASSESSMENTS AND ACCOUNTABILITY SYSTEMS, THEREBY INFLUENCING CURRICULUM ALIGNMENT AND INSTRUCTIONAL PRACTICES.
