FUNDING AND RESOURCE ALLOCATION

HOWEVER, CURRENT ISSUES IN SPECIAL NEEDS EDUCATION HIGHLIGHT A SHORTAGE OF ADEQUATELY PREPARED TEACHERS AND LIMITED ONGOING PROFESSIONAL DEVELOPMENT OPPORTUNITIES.

PRE-SERVICE TRAINING GAPS
