CANDIDATES MUST ALSO INTERPRET WELDING PROCEDURE SPECIFICATIONS (WPS) AND PROCEDURE QUALIFICATION RECORDS (PQR), ENSURING THAT WELDING OPERATIONS ADHERE TO APPROVED STANDARDS.

WELDING INSPECTION TECHNIQUES
