The general objective was to establish a Uniform Commercial Code for this ascending sector of commerce in order to facilitate and enforce electronic transactions. The legislative efforts to achieve those goals recently resulted in two uniform acts, the Uniform Computer Information Transactions Act (UCITA) and the Uniform

Electronic Transactions Act (UETA), and the federal Electronic Signatures in Global and National Commerce Act (E-sign Act). The paper deals with these new legislative approaches. Aside from the presentation of the scopes of the different acts the paper focuses on their fundamental principles and major provisions. Furthermore, it discusses the new enactments in the context of a selection of fundamental legal issues raised by electronic commerce. This discussion finally shows that, although there have been a number of serious endeavors to achieve the above mentioned goals by drafting several electronic commerce statutes, the recent enactments relating to contract law in electronic commerce are not able to achieve the goals set out in the Framework for Global Electronic Commerce. There still remain significant legal obstacles that prohibit electronic commerce from reaching its full potential.
