EDUCATIONAL AND LICENSING REQUIREMENTS

SALARY RANGE AND JOB OUTLOOK

MAJOR CITIES VS. RURAL AREAS

COST OF LIVING CONSIDERATIONS

WHILE SALARIES MAY BE HIGHER IN URBAN AREAS, THE INCREASED COST OF LIVING CAN OFFSET THESE DIFFERENCES. RURAL AREAS MAY OFFER LOWER SALARIES BUT ALSO TEND TO HAVE LOWER LIVING EXPENSES, WHICH CAN BE A CONSIDERATION FOR PROFESSIONALS BALANCING INCOME WITH LIFESTYLE PREFERENCES.

CAREER ADVANCEMENT AND SPECIALIZATIONS
