For unmarried recent high school graduates, the prospect of getting a job was mostly non-existent. From the first day, the camp was activated through the last day of operation, the book is filled with accounts of camp development, work projects, construction of the dam creating Poe Valley lake, and numerous stories told by veterans, camp administrators, and military commanders. Included are hundreds of names of rostered enrollees. Anyone interested in learning what life was like in a CCC camp during and after work hours, this book will provide insight into camp operations and activities.
