## UNDERSTANDING FORM 8829 AND ITS PURPOSE

FORM 8829, OFFICIALLY TITLED "EXPENSES FOR BUSINESS USE OF YOUR HOME," IS A TAX DOCUMENT PROVIDED BY THE IRS ALLOWING SELF-EMPLOYED TAXPAYERS TO CLAIM DEDUCTIONS FOR COSTS RELATED TO USING PART OF THEIR HOME FOR BUSINESS ACTIVITIES. THIS FORM IS PRIMARILY USED BY SOLE PROPRIETORS AND INDEPENDENT CONTRACTORS WHO OPERATE THEIR BUSINESS FROM A HOME OFFICE OR WORKSPACE. THE MAIN PURPOSE OF FORM 8829 IS TO CALCULATE THE ALLOWABLE EXPENSES THAT CAN BE DEDUCTED FROM BUSINESS INCOME, THEREBY REDUCING OVERALL TAXABLE INCOME. THESE DEDUCTIONS CAN INCLUDE MORTGAGE INTEREST, UTILITIES, INSURANCE, REPAIRS, AND DEPRECIATION, ALLOCATED BASED ON THE PERCENTAGE OF THE HOME USED FOR BUSINESS.

## WHY FORM 8829 IS IMPORTANT

UTILIZING FORM 8829 CORRECTLY ENSURES COMPLIANCE WITH IRS REGULATIONS AND MAXIMIZES TAX BENEFITS. ## ELIGIBILITY CRITERIA FOR BUSINESS USE OF HOME DEDUCTION

THIS MEANS THE SPACE IS NOT USED FOR PERSONAL ACTIVITIES AND IS THE PRINCIPAL PLACE OF BUSINESS OR A PLACE TO MEET CLIENTS OR CUSTOMERS.

## KEY ELIGIBILITY REQUIREMENTS

THE MAIN CRITERIA FOR CLAIMING A BUSINESS USE OF HOME DEDUCTION INCLUDE:

- **EXCLUSIVE USE:** THE AREA CLAIMED MUST BE USED ONLY FOR BUSINESS AND NOT FOR PERSONAL USE AT ANY TIME.
- **REGULAR USE:** THE HOME OFFICE MUST BE USED CONSISTENTLY FOR BUSINESS ACTIVITIES.
- **PRINCIPAL PLACE OF BUSINESS:** THE HOME OFFICE SHOULD BE THE PRIMARY LOCATION WHERE BUSINESS IS CONDUCTED, OR A PLACE WHERE CLIENTS OR CUSTOMERS ARE REGULARLY MET.
- **SEPARATE STRUCTURE:** ALTERNATIVELY, A SEPARATE UNATTACHED STRUCTURE USED EXCLUSIVELY FOR BUSINESS QUALIFIES.

FAILURE TO MEET THESE REQUIREMENTS GENERALLY DISQUALIFIES A TAXPAYER FROM USING FORM 8829 FOR HOME OFFICE EXPENSES.

## CALCULATING BUSINESS USE PERCENTAGE

THE BUSINESS USE PERCENTAGE IS A CRITICAL FIGURE IN COMPLETING FORM 8829, AS IT DETERMINES THE PORTION OF HOME EXPENSES DEDUCTIBLE. THIS PERCENTAGE IS CALCULATED BY DIVIDING THE AREA USED FOR BUSINESS BY THE TOTAL AREA OF THE HOME.

## METHODS TO CALCULATE BUSINESS USE PERCENTAGE

THERE ARE TWO COMMON METHODS FOR CALCULATING THE BUSINESS USE PERCENTAGE:

- **SQUARE FOOTAGE METHOD:** MEASURE THE SQUARE FOOTAGE OF THE OFFICE SPACE AND DIVIDE IT BY THE TOTAL SQUARE FOOTAGE OF THE HOME.
- **ROOM COUNT METHOD:** IF ROOMS ARE ROUGHLY EQUAL IN SIZE, COUNT THE NUMBER OF ROOMS USED FOR BUSINESS DIVIDED BY THE TOTAL NUMBER OF ROOMS.

THE SQUARE FOOTAGE METHOD IS THE MOST ACCURATE AND WIDELY RECOMMENDED APPROACH BY TAX PROFESSIONALS.

## TYPES OF EXPENSES DEDUCTIBLE ON FORM 8829

FORM 8829 ALLOWS DEDUCTIONS FOR VARIOUS EXPENSES RELATED TO THE BUSINESS USE OF A HOME. THESE EXPENSES ARE CATEGORIZED AS DIRECT OR INDIRECT, DEPENDING ON HOW THEY RELATE TO THE BUSINESS AREA OF THE HOME.

### DIRECT EXPENSES

DIRECT EXPENSES ARE COSTS INCURRED EXCLUSIVELY FOR THE BUSINESS PART OF THE HOME. EXAMPLES INCLUDE PAINTING OR REPAIRING THE HOME OFFICE SPACE. THESE EXPENSES ARE FULLY DEDUCTIBLE AGAINST THE BUSINESS USE OF HOME.

### INDIRECT EXPENSES

INDIRECT EXPENSES ARE COSTS FOR MAINTAINING THE ENTIRE HOME, SUCH AS MORTGAGE INTEREST, UTILITIES, INSURANCE, AND

GENERAL REPAIRS. THESE EXPENSES ARE DEDUCTIBLE ONLY IN PROPORTION TO THE BUSINESS USE PERCENTAGE.

## COMMON DEDUCTIBLE EXPENSES

- MORTGAGE INTEREST OR RENT PAYMENTS
- HOMEOWNERS OR RENTERS INSURANCE
- UTILITIES SUCH AS ELECTRICITY, WATER, AND GAS
- REPAIRS AND MAINTENANCE
- DEPRECIATION OF THE HOME
- SECURITY SYSTEM EXPENSES

## HOW TO COMPLETE FORM 8829 STEP-BY-STEP

FILLING OUT FORM 8829 REQUIRES CAREFUL CALCULATION AND ACCURATE INFORMATION TO ENSURE THE CORRECT DEDUCTION AMOUNT. THE FORM IS DIVIDED INTO SEVERAL PARTS THAT GUIDE THE TAXPAYER THROUGH THE PROCESS.

### PART I: CALCULATION OF BUSINESS USE PERCENTAGE

THIS SECTION REQUIRES ENTERING THE TOTAL SQUARE FOOTAGE OF THE HOME AND THE PORTION USED FOR BUSINESS. THE BUSINESS USE PERCENTAGE IS THEN CALCULATED AUTOMATICALLY.

### PART II: FIGURE EXPENSES FOR BUSINESS USE OF YOUR HOME

HERE, TAXPAYERS LIST DIRECT AND INDIRECT EXPENSES AND APPLY THE BUSINESS USE PERCENTAGE TO INDIRECT EXPENSES. DEPRECIATION IS ALSO CALCULATED IN THIS PART.

### PART III: CARRYOVER OF UNALLOWED EXPENSES

IF EXPENSES EXCEED GROSS INCOME FROM THE BUSINESS USE OF THE HOME, UNALLOWED EXPENSES MAY BE CARRIED OVER TO THE NEXT TAX YEAR. THIS SECTION HELPS TRACK THOSE AMOUNTS.

### PART IV: DEPRECIATION

DEPRECIATION ON THE BUSINESS PORTION OF THE HOME IS CALCULATED HERE, BASED ON THE ADJUSTED BASIS OR FAIR MARKET VALUE AND THE BUSINESS USE PERCENTAGE.

## RECORDKEEPING AND DOCUMENTATION REQUIREMENTS

MAINTAINING THOROUGH RECORDS AND DOCUMENTATION IS ESSENTIAL WHEN CLAIMING DEDUCTIONS ON FORM 8829. THE IRS REQUIRES PROOF OF BUSINESS USE AND SUPPORTING DOCUMENTS FOR EXPENSES CLAIMED.

## TYPES OF RECORDS TO KEEP

- RECEIPTS AND INVOICES FOR REPAIRS, UTILITIES, AND OTHER EXPENSES
- MORTGAGE STATEMENTS OR RENT AGREEMENTS
- UTILITY BILLS SHOWING PAYMENTS
- FLOOR PLANS OR MEASUREMENTS OF HOME OFFICE SPACE
- DEPRECIATION SCHEDULES

PROPER DOCUMENTATION SUBSTANTIATES DEDUCTIONS IN CASE OF AN IRS AUDIT AND ENSURES COMPLIANCE WITH TAX LAWS.

## COMMON MISTAKES AND HOW TO AVOID THEM

EXPENSES THAT CAN BE DEDUCTED INCLUDE MORTGAGE INTEREST, RENT, UTILITIES, INSURANCE, REPAIRS, AND DEPRECIATION RELATED TO THE PORTION OF THE HOME USED FOR BUSINESS.

## HOW IS THE ALLOWABLE DEDUCTION CALCULATED ON FORM 8829?

THE DEDUCTION IS CALCULATED BASED ON THE PERCENTAGE OF THE HOME USED FOR BUSINESS, DETERMINED BY DIVIDING THE AREA USED FOR BUSINESS BY THE TOTAL AREA OF THE HOME, APPLIED TO ELIGIBLE EXPENSES.

## CAN FORM 8829 BE USED FOR RENTAL PROPERTIES OR ONLY FOR PRIMARY RESIDENCES?

FORM 8829 IS SPECIFICALLY FOR BUSINESS USE OF A HOME, TYPICALLY A PRIMARY RESIDENCE OR A PLACE WHERE A TAXPAYER REGULARLY CONDUCTS BUSINESS, NOT FOR RENTAL PROPERTIES.

## IS THERE A SIMPLIFIED METHOD FOR CLAIMING THE HOME OFFICE DEDUCTION INSTEAD OF USING FORM 8829?

YES, THE IRS OFFERS A SIMPLIFIED OPTION THAT ALLOWS A STANDARD DEDUCTION OF \$5 PER SQUARE FOOT OF HOME USED FOR BUSINESS, UP TO 300 SQUARE FEET, WHICH DOES NOT REQUIRE FILING FORM 8829.

## WHAT RECORDS SHOULD BE KEPT TO SUPPORT THE EXPENSES CLAIMED ON FORM 8829?

TAXPAYERS SHOULD KEEP RECORDS SUCH AS MORTGAGE STATEMENTS, UTILITY BILLS, INSURANCE DOCUMENTS, REPAIR RECEIPTS, AND DETAILED MEASUREMENTS OF THE BUSINESS-USE AREA OF THE HOME.

## CAN FORM 8829 BE FILED ELECTRONICALLY WITH THE REST OF THE TAX RETURN?

YES, FORM 8829 CAN BE FILED ELECTRONICALLY AS PART OF THE SCHEDULE C ATTACHMENT WHEN E-FILEING A TAX RETURN.

## WHAT HAPPENS IF THE BUSINESS USE PERCENTAGE OF THE HOME CHANGES DURING THE YEAR?

IF THE BUSINESS USE PERCENTAGE CHANGES DURING THE YEAR, TAXPAYERS MUST CALCULATE THE DEDUCTION BASED ON THE AVERAGE PERCENTAGE OF BUSINESS USE DURING THE YEAR OR ALLOCATE EXPENSES ACCORDINGLY ON FORM 8829.
