SIMILARLY, THE QUILL OR PEN HAS SYMBOLIZED THE IMPORTANCE OF WRITTEN EXPRESSION AND THE DISSEMINATION OF IDEAS SINCE THE ADVENT OF PRINTING TECHNOLOGY.

ENLIGHTENMENT AND THE RISE OF FREE SPEECH SYMBOLS

EVOLUTION THROUGH POLITICAL MOVEMENTS

EVOLVE TO SUIT CONTEMPORARY CONTEXTS.

COMMON SYMBOLS REPRESENTING FREEDOM OF SPEECH

THE TORCH

THE RAISED FIST

THE RAISED FIST IS A POWERFUL SYMBOL OF RESISTANCE AND SOLIDARITY, FREQUENTLY ASSOCIATED WITH SOCIAL JUSTICE MOVEMENTS.
