This increased range not only expands the list of ways states can die; it also provides insights into whether diplomatic recognition is associated with longer life and shows that state strength is not related to state death. Similarly, in contrast to the conventional wisdom, victories in conflict do not coincide with longer state survival. State death is one of the central questions within international relations, and Lemke's reformulation of what a state is will transform our understanding of how and why these deaths happen.
