 $0\grave{u}$  is used to indicate place or time and can be translated as "where," "when," or "in which." It introduces relative clauses specifying location or temporal context.

- Examples: La ville où je suis né est belle. (The city where I was born is beautiful.)
- Le moment où il est arrivé était crucial. (The moment when he arrived was crucial.)

## Common Errors in Using French Relative Pronouns
