OVERVIEW OF THE ILLINOIS PHYSICAL THERAPY PRACTICE ACT

THE ACT ALSO OUTLINES THE AUTHORITY AND RESPONSIBILITIES OF THE REGULATORY BOARD TASKED WITH OVERSEEING THE PROFESSION. EDUCATIONAL AND EXAMINATION CRITERIA

FOLLOWING EDUCATION, CANDIDATES ARE REQUIRED TO PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE), WHICH ASSESSES THEIR COMPETENCY AND KNOWLEDGE. THE ACT MANDATES THAT LICENSEES MAINTAIN COMPLIANCE WITH CONTINUING EDUCATION REQUIREMENTS TO UPHOLD THEIR PROFESSIONAL QUALIFICATIONS.

APPLICATION PROCESS

THE LICENSURE APPLICATION INVOLVES SUBMITTING PROOF OF EDUCATION, EXAMINATION RESULTS, AND ANY OTHER DOCUMENTATION REQUIRED BY THE REGULATORY BOARD. PHYSICAL THERAPIST ASSISTANTS WORK UNDER THE DIRECTION AND SUPERVISION OF LICENSED PHYSICAL THERAPISTS TO CARRY OUT TREATMENT PLANS.

LIMITATIONS AND RESTRICTIONS

THE ACT PROHIBITS PHYSICAL THERAPISTS AND ASSISTANTS FROM ENGAGING IN ACTIVITIES BEYOND THEIR PROFESSIONAL TRAINING AND LICENSURE. FOR INSTANCE, THEY MAY NOT PRESCRIBE MEDICATIONS OR PERFORM SURGERIES. IT ALSO REGULATES THE EXTENT OF SUPERVISION AND DELEGATION BETWEEN THERAPISTS AND ASSISTANTS TO ENSURE SAFE CARE DELIVERY.

PROFESSIONAL CONDUCT AND DISCIPLINARY ACTIONS

- NEGLIGENCE OR INCOMPETENCE IN PATIENT CARE
- VIOLATION OF PATIENT CONFIDENTIALITY

DISCIPLINARY ACTIONS RANGE FROM FINES AND LICENSE SUSPENSION TO REVOCATION, DEPENDING ON THE SEVERITY OF THE OFFENSE.

ROLE OF THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION

THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR) IS THE STATE AGENCY RESPONSIBLE FOR ENFORCING THE PROVISIONS OF THE PHYSICAL THERAPY PRACTICE ACT. THE DEPARTMENT OVERSEES LICENSURE, MONITORS COMPLIANCE, INVESTIGATES COMPLAINTS, AND ADMINISTERS DISCIPLINARY PROCEEDINGS.

LICENSING AND RENEWAL OVERSIGHT

IDFPR PROCESSES APPLICATIONS FOR INITIAL LICENSURE AND RENEWALS, ENSURING THAT ALL CANDIDATES MEET THE ACT'S REQUIREMENTS. THE DEPARTMENT MAINTAINS AN ACTIVE REGISTRY OF LICENSED PHYSICAL THERAPISTS AND ASSISTANTS, PROVIDING TRANSPARENCY AND PUBLIC ACCESS TO LICENSE STATUS INFORMATION.
