ILLINOIS DRIVER'S PERMIT REQUIREMENTS

FEES AND APPLICATION PROCESS

AN APPLICATION FEE IS CHARGED WHEN APPLYING FOR THE LEARNER'S PERMIT. THE FEE VARIES DEPENDING ON THE APPLICANT'S AGE AND LICENSE TYPE. IT IS ADVISABLE TO CHECK THE LATEST FEE SCHEDULE BEFORE VISITING A SECRETARY OF STATE DRIVER SERVICES FACILITY. THE APPLICATION PROCESS ALSO INCLUDES COMPLETING A VISION SCREENING AND THE WRITTEN KNOWLEDGE TEST.
