SUCH PROGRAMS OFTEN PROVIDE COMPREHENSIVE INSTRUCTION ON PHARMACEUTICAL CALCULATIONS, DRUG CLASSIFICATIONS, AND PHARMACY LAW, WHICH ARE ADVANTAGEOUS DURING THE LICENSING EXAMINATION.

APPLICATION PROCESS AND REQUIRED DOCUMENTATION

APPLICATION FEES

APPLICANTS MUST PAY A NON-REFUNDABLE APPLICATION FEE AS DETERMINED BY THE IDFPR. FEE AMOUNTS ARE SUBJECT TO CHANGE, SO IT IS IMPORTANT TO VERIFY THE CURRENT FEE SCHEDULE BEFORE SUBMISSION.

LICENSING EXAMINATION AND CERTIFICATION

PASSING A CERTIFICATION EXAMINATION IS A KEY COMPONENT OF THE ILLINOIS PHARMACY TECHNICIAN LICENSING PROCESS. THIS EXAMINATION EVALUATES THE APPLICANT'S KNOWLEDGE AND COMPETENCE IN PHARMACY-RELATED TASKS.

APPROVED CERTIFICATION EXAMS

EXAM PREPARATION

RENEWAL AND CONTINUING EDUCATION REQUIREMENTS

MAINTAINING AN ILLINOIS PHARMACY TECHNICIAN LICENSE REQUIRES TIMELY RENEWAL AND FULFILLMENT OF CONTINUING EDUCATION (CE) REQUIREMENTS. THESE MEASURES ENSURE TECHNICIANS REMAIN KNOWLEDGEABLE ABOUT EVOLVING PHARMACEUTICAL PRACTICES AND REGULATIONS.

LICENSE RENEWAL PROCESS

PHARMACY TECHNICIAN LICENSES IN ILLINOIS MUST BE RENEWED EVERY TWO YEARS. RENEWAL APPLICATIONS ARE SUBMITTED THROUGH THE IDFPR'S ONLINE PORTAL OR VIA MAIL, ACCOMPANIED BY THE APPLICABLE RENEWAL FEE.

CONTINUING EDUCATION OBLIGATIONS

LICENSEES MUST COMPLETE AT LEAST 20 HOURS OF APPROVED CONTINUING EDUCATION DURING EACH RENEWAL CYCLE, INCLUDING A MINIMUM OF ONE HOUR FOCUSED ON PHARMACY LAW AND ONE HOUR ON PATIENT SAFETY. CE COURSES CAN BE OBTAINED THROUGH ACCREDITED PROVIDERS AND MUST BE RELEVANT TO PHARMACY TECHNICIAN DUTIES.

FAILURE TO RENEW

FAILURE TO RENEW THE LICENSE ON TIME MAY RESULT IN SUSPENSION OR REVOCATION. ILLINOIS ALLOWS A GRACE PERIOD FOR RENEWAL, BUT AFTER THIS PERIOD, REINSTATEMENT MAY REQUIRE ADDITIONAL STEPS SUCH AS RETAKING THE CERTIFICATION EXAM OR SUBMITTING A NEW APPLICATION.

ROLES AND RESPONSIBILITIES OF LICENSED PHARMACY TECHNICIANS

LICENSED PHARMACY TECHNICIANS IN ILLINOIS PLAY AN INTEGRAL ROLE IN SUPPORTING PHARMACISTS AND ENSURING THE SAFE DISPENSING OF MEDICATIONS. THEIR RESPONSIBILITIES ARE GOVERNED BY STATE LAWS AND PROFESSIONAL STANDARDS DESIGNED TO PROTECT PUBLIC HEALTH.

CORE DUTIES

PHARMACY TECHNICIANS ASSIST PHARMACISTS BY PERFORMING TASKS SUCH AS:

- PROCESSING PRESCRIPTION ORDERS
- PREPARING AND LABELING MEDICATIONS
- MANAGING INVENTORY AND ORDERING SUPPLIES
- MAINTAINING PATIENT RECORDS AND CONFIDENTIALITY
- PROVIDING CUSTOMER SERVICE AND ASSISTING WITH MEDICATION INQUIRIES

SCOPE OF PRACTICE LIMITATIONS

ILLINOIS LAW RESTRICTS CERTAIN ACTIVITIES TO LICENSED PHARMACISTS ONLY, SUCH AS COUNSELING PATIENTS ON PRESCRIPTIONS AND FINAL VERIFICATION OF MEDICATIONS. PHARMACY TECHNICIANS MUST OPERATE UNDER THE SUPERVISION OF A LICENSED PHARMACIST AT ALL TIMES AND ADHERE STRICTLY TO THE SCOPE OF THEIR AUTHORIZED DUTIES.

PROFESSIONAL CONDUCT AND COMPLIANCE

LICENSED PHARMACY TECHNICIANS ARE EXPECTED TO UPHOLD ETHICAL STANDARDS, COMPLY WITH STATE AND FEDERAL REGULATIONS, AND PARTICIPATE IN ONGOING PROFESSIONAL DEVELOPMENT. VIOLATIONS OF PHARMACY LAWS OR ETHICAL BREACHES CAN LEAD TO DISCIPLINARY ACTION, INCLUDING LICENSE SUSPENSION OR REVOCATION.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE BASIC ELIGIBILITY REQUIREMENTS FOR AN ILLINOIS PHARMACY TECHNICIAN LICENSE?

WHAT FEES ARE ASSOCIATED WITH OBTAINING AND RENEWING A PHARMACY TECHNICIAN LICENSE IN ILLINOIS?

THE INITIAL APPLICATION FEE IS TYPICALLY AROUND \$50, AND THE RENEWAL FEE IS ALSO APPROXIMATELY \$50, BUT APPLICANTS SHOULD CHECK THE IDFPR WEBSITE FOR THE MOST CURRENT FEE SCHEDULE.
