NOT ALL REASONS FOR TERMINATION QUALIFY AS MISCONDUCT. FOR EXAMPLE, POOR PERFORMANCE OR INABILITY TO MEET JOB EXPECTATIONS TYPICALLY DOES NOT CONSTITUTE MISCONDUCT UNDER ILLINOIS UNEMPLOYMENT REGULATIONS.

LEGAL FRAMEWORK GOVERNING MISCONDUCT CLAIMS

PREPARING FOR THE ILLINOIS UNEMPLOYMENT MISCONDUCT 602A PHONE INTERVIEW

HAVING THESE READY BEFORE THE INTERVIEW ENSURES ACCURATE AND CONFIDENT RESPONSES.

TIPS FOR EFFECTIVE COMMUNICATION DURING THE INTERVIEW

CLAIMANTS SHOULD REMAIN CALM, HONEST, AND CONCISE WHEN ANSWERING QUESTIONS. IT IS ADVISABLE TO:

- LISTEN CAREFULLY AND ASK FOR CLARIFICATION IF NECESSARY
- STICK TO FACTS AND AVOID EMOTIONAL OR EXAGGERATED STATEMENTS
- DO NOT VOLUNTEER UNNECESSARY INFORMATION
- BE RESPECTFUL AND PROFESSIONAL THROUGHOUT THE CONVERSATION

CLEAR AND CONSISTENT COMMUNICATION CAN IMPROVE THE CHANCES OF A FAVORABLE DECISION.

COMMON ISSUES AND CHALLENGES
