ILLINOIS STATE BOARD OF EDUCATION LICENSURE IS A CRITICAL CREDENTIAL FOR EDUCATORS SEEKING TO TEACH IN ILLINOIS PUBLIC SCHOOLS. OVERVIEW OF ILLINOIS STATE BOARD OF EDUCATION LICENSURE

THE ILLINOIS STATE BOARD OF EDUCATION LICENSURE SYSTEM ENSURES THAT EDUCATORS ADHERE TO ESTABLISHED PROFESSIONAL STANDARDS IN TEACHING AND ADMINISTRATION. LICENSURE IS MANDATORY FOR INDIVIDUALS SEEKING EMPLOYMENT IN PUBLIC SCHOOLS ACROSS ILLINOIS AND SERVES AS A BENCHMARK FOR EDUCATOR QUALIFICATIONS. THE ISBE IS RESPONSIBLE FOR FORMULATING LICENSURE POLICIES, EVALUATING APPLICATIONS, AND ISSUING CREDENTIALS THAT COMPLY WITH STATE EDUCATIONAL LAWS. LICENSURE SUPPORTS THE STATE'S COMMITMENT TO QUALITY EDUCATION BY REGULATING WHO IS QUALIFIED TO INSTRUCT STUDENTS. THIS PROCESS HELPS MAINTAIN A PROFESSIONAL TEACHING WORKFORCE EQUIPPED WITH THE NECESSARY KNOWLEDGE AND SKILLS.

TYPES OF LICENSES OFFERED

THE ILLINOIS STATE BOARD OF EDUCATION OFFERS SEVERAL TYPES OF LICENSES TAILORED TO DIFFERENT EDUCATIONAL ROLES AND LEVELS. EACH LICENSE TYPE CORRESPONDS TO SPECIFIC QUALIFICATIONS AND RESPONSIBILITIES WITHIN THE EDUCATIONAL SYSTEM. THE PRIMARY LICENSES INCLUDE:

- **PROFESSIONAL EDUCATOR LICENSE (PEL):** THE STANDARD LICENSE FOR TEACHERS, ADMINISTRATORS, AND OTHER EDUCATIONAL PROFESSIONALS WHO MEET ALL PREPARATION AND TESTING REQUIREMENTS.
- **EDUCATOR LICENSURE WITH STIPULATIONS:** TEMPORARY LICENSES ISSUED UNDER SPECIFIC CONDITIONS, USUALLY WHEN CANDIDATES ARE COMPLETING REQUIREMENTS.
- **SUBSTITUTE TEACHING LICENSE:** ALLOWS INDIVIDUALS TO SERVE AS SUBSTITUTE TEACHERS IN ILLINOIS SCHOOLS.
- **PARAPROFESSIONAL LICENSE:** FOR EDUCATIONAL SUPPORT STAFF WORKING UNDER TEACHER SUPERVISION.
- **ADMINISTRATIVE LICENSES:** FOR SCHOOL PRINCIPALS, SUPERINTENDENTS, AND OTHER LEADERSHIP ROLES REQUIRING

SPECIALIZED CREDENTIALS.

EACH LICENSE TYPE HAS UNIQUE CRITERIA AND DURATIONS, ENSURING THAT EDUCATORS ARE APPROPRIATELY CREDENTIALLED FOR THEIR SPECIFIC ROLES.

ELIGIBILITY AND APPLICATION PROCESS

ELIGIBILITY FOR THE ILLINOIS STATE BOARD OF EDUCATION LICENSURE DEPENDS ON EDUCATIONAL BACKGROUND, TESTING, AND PREPARATION PROGRAM COMPLETION. GENERALLY, CANDIDATES MUST HOLD AT LEAST A BACHELOR'S DEGREE FROM AN ACCREDITED INSTITUTION AND COMPLETE AN APPROVED EDUCATOR PREPARATION PROGRAM. ADDITIONALLY, PASSING STATE-REQUIRED EXAMS SUCH AS THE ILLINOIS LICENSURE TESTING SYSTEM (ILTS) IS MANDATORY.

REQUIRED TESTING AND EDUCATIONAL QUALIFICATIONS

CANDIDATES MUST PASS MULTIPLE ASSESSMENTS THAT EVALUATE CONTENT-AREA KNOWLEDGE AND TEACHING SKILLS. THESE INCLUDE:

- CONTENT-AREA TESTS SPECIFIC TO THE TEACHING SUBJECT
- ASSESSMENT OF PROFESSIONAL TEACHING (APT)
- BASIC SKILLS TESTS OR ALTERNATIVE ASSESSMENTS AS APPLICABLE

COMPLETION OF A STATE-APPROVED EDUCATOR PREPARATION PROGRAM THAT INCLUDES STUDENT TEACHING EXPERIENCE IS ALSO REQUIRED.

APPLICATION SUBMISSION AND DOCUMENTATION

APPLICANTS SUBMIT THEIR LICENSURE APPLICATIONS THROUGH THE ISBE ONLINE PORTAL OR BY MAIL, PROVIDING TRANSCRIPTS, TEST SCORES, BACKGROUND CHECKS, AND PROOF OF COMPLETION OF PREPARATION PROGRAMS. THE ILLINOIS STATE BOARD OF EDUCATION REVIEWS APPLICATIONS TO VERIFY ELIGIBILITY BEFORE ISSUING LICENSES.

RENEWAL AND CONTINUING PROFESSIONAL DEVELOPMENT

THE ILLINOIS STATE BOARD OF EDUCATION LICENSURE REQUIRES PERIODIC RENEWAL TO ENSURE EDUCATORS REMAIN CURRENT WITH EVOLVING EDUCATIONAL STANDARDS. RENEWAL TYPICALLY OCCURS EVERY FIVE YEARS AND INVOLVES COMPLETING CONTINUING PROFESSIONAL DEVELOPMENT (CPD) HOURS.

CONTINUING PROFESSIONAL DEVELOPMENT REQUIREMENTS

EDUCATORS MUST COMPLETE PROFESSIONAL LEARNING ACTIVITIES THAT ENHANCE THEIR SKILLS AND KNOWLEDGE. THESE ACTIVITIES MAY INCLUDE WORKSHOPS, COURSEWORK, CONFERENCES, OR OTHER APPROVED EDUCATIONAL EXPERIENCES. THE ISBE OUTLINES SPECIFIC CPD HOUR REQUIREMENTS BASED ON LICENSE TYPE.

RENEWAL PROCESS

TO RENEW A LICENSE, EDUCATORS MUST SUBMIT DOCUMENTATION OF COMPLETED CPD HOURS AND PAY ANY APPLICABLE FEES. FAILURE TO RENEW ON TIME CAN RESULT IN LICENSE EXPIRATION, REQUIRING ADDITIONAL STEPS TO REINSTATE CREDENTIALS.

ENDORSEMENTS AND SPECIALIZED LICENSES

THE ILLINOIS STATE BOARD OF EDUCATION OFFERS ENDORSEMENTS AND SPECIALIZED LICENSES TO EXPAND AN EDUCATOR'S QUALIFICATIONS AND AUTHORIZE TEACHING IN SPECIFIC SUBJECT AREAS OR ROLES. THESE ENDORSEMENTS ALLOW PROFESSIONALS TO DEMONSTRATE EXPERTISE BEYOND THEIR PRIMARY LICENSURE.

COMMON ENDORSEMENTS

- **SPECIAL EDUCATION ENDORSEMENT:** FOR TEACHERS WORKING WITH STUDENTS WITH DISABILITIES.
- **ENGLISH AS A SECOND LANGUAGE (ESL):** FOR EDUCATORS SUPPORTING ENGLISH LANGUAGE LEARNERS.
- **READING SPECIALIST:** FOCUSED ON LITERACY AND READING INSTRUCTION.
- **TECHNOLOGY INTEGRATION:** FOR EDUCATORS INCORPORATING TECHNOLOGY INTO INSTRUCTIONAL PRACTICES.

OBTAINING ENDORSEMENTS

ENDORSEMENTS REQUIRE ADDITIONAL COURSEWORK, TESTING, OR EXPERIENCE. EDUCATORS MUST SUBMIT APPLICATIONS FOR ENDORSEMENTS SEPARATELY THROUGH THE ISBE, DEMONSTRATING FULFILLMENT OF ALL RELEVANT REQUIREMENTS.

ROLE OF THE ILLINOIS STATE BOARD OF EDUCATION IN LICENSURE

THE ILLINOIS STATE BOARD OF EDUCATION PLAYS A CENTRAL ROLE IN REGULATING EDUCATOR LICENSURE, ENSURING THE INTEGRITY AND QUALITY OF THE TEACHING WORKFORCE. THE BOARD ESTABLISHES LICENSURE STANDARDS, APPROVES EDUCATOR PREPARATION PROGRAMS, AND MONITORS COMPLIANCE WITH STATE LAWS. ISBE ALSO MAINTAINS THE ONLINE LICENSURE SYSTEM, FACILITATING APPLICATION, RENEWAL, AND VERIFICATION PROCESSES FOR EDUCATORS AND EMPLOYERS.

MOREOVER, THE BOARD COLLABORATES WITH INSTITUTIONS OF HIGHER EDUCATION, PROFESSIONAL ORGANIZATIONS, AND POLICYMAKERS TO CONTINUOUSLY IMPROVE LICENSURE STANDARDS AND ADDRESS EMERGING EDUCATIONAL NEEDS. THROUGH THESE EFFORTS, THE ILLINOIS STATE BOARD OF EDUCATION LICENSURE SYSTEM SUPPORTS EFFECTIVE TEACHING AND CONTRIBUTES TO STUDENT SUCCESS ACROSS THE STATE.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE ILLINOIS STATE BOARD OF EDUCATION LICENSURE?

THE ILLINOIS STATE BOARD OF EDUCATION LICENSURE IS A CERTIFICATION PROCESS OVERSEEN BY THE ILLINOIS STATE BOARD OF EDUCATION (ISBE) THAT AUTHORIZES INDIVIDUALS TO WORK AS EDUCATORS IN ILLINOIS PUBLIC SCHOOLS.

HOW DO I APPLY FOR A TEACHING LICENSE THROUGH THE ILLINOIS STATE BOARD OF EDUCATION?

TO APPLY FOR A TEACHING LICENSE IN ILLINOIS, YOU MUST COMPLETE AN APPROVED EDUCATOR PREPARATION PROGRAM, PASS REQUIRED EXAMS, AND SUBMIT AN APPLICATION THROUGH THE ILLINOIS EDUCATOR LICENSURE INFORMATION SYSTEM (ELIS) ON THE ISBE WEBSITE.

WHAT TYPES OF LICENSURE ARE AVAILABLE THROUGH THE ILLINOIS STATE BOARD OF EDUCATION?

ISBE OFFERS SEVERAL TYPES OF LICENSURE INCLUDING PROFESSIONAL EDUCATOR LICENSE (PEL), EDUCATOR LICENSURE WITH STIPULATIONS (ELS), SUBSTITUTE LICENSE, AND ADMINISTRATIVE LICENSES, AMONG OTHERS.

WHAT EXAMS ARE REQUIRED FOR ILLINOIS STATE BOARD OF EDUCATION LICENSURE?

APPLICANTS TYPICALLY MUST PASS THE ILLINOIS LICENSURE TESTING SYSTEM (ILTS) EXAMS, WHICH MAY INCLUDE TESTS ON CONTENT AREA KNOWLEDGE, BASIC SKILLS, AND PEDAGOGY DEPENDING ON THE LICENSE SOUGHT.

CAN I TRANSFER MY TEACHING LICENSE FROM ANOTHER STATE TO ILLINOIS?

YES, ILLINOIS OFFERS LICENSURE BY RECIPROCITY FOR EDUCATORS HOLDING A VALID LICENSE IN ANOTHER STATE, BUT APPLICANTS MUST MEET SPECIFIC REQUIREMENTS AND APPLY THROUGH THE ISBE LICENSURE SYSTEM.

HOW LONG DOES IT TAKE TO GET AN ILLINOIS TEACHING LICENSE AFTER APPLYING?

PROCESSING TIMES VARY, BUT GENERALLY, IT TAKES SEVERAL WEEKS TO A COUPLE OF MONTHS FOR THE ILLINOIS STATE BOARD OF EDUCATION TO REVIEW AND APPROVE LICENSURE APPLICATIONS ONCE ALL REQUIREMENTS ARE MET.

WHAT ARE THE RENEWAL REQUIREMENTS FOR AN ILLINOIS TEACHING LICENSE?

ILLINOIS TEACHING LICENSES TYPICALLY REQUIRE RENEWAL EVERY FIVE YEARS, WHICH INVOLVES COMPLETING PROFESSIONAL DEVELOPMENT UNITS (PDUs) OR COURSEWORK AND SUBMITTING A RENEWAL APPLICATION THROUGH ELIS.
