- SIGNATURE AND LICENSE NUMBER OF THE EYE CARE PROFESSIONAL
- Date of examination

# WHO NEEDS TO COMPLETE THE ILLINOIS STATE EYE EXAM FORM

SEVERAL GROUPS OF INDIVIDUALS IN ILLINOIS ARE REQUIRED TO COMPLETE THE STATE EYE EXAM FORM AS PART OF REGULATORY OR INSTITUTIONAL REQUIREMENTS. UNDERSTANDING WHO MUST UNDERGO THIS EXAMINATION HELPS ENSURE COMPLIANCE WITH STATE LAWS AND AVOIDS POTENTIAL DELAYS OR PENALTIES.

## SCHOOL CHILDREN

# VISION REQUIREMENTS AND STANDARDS IN ILLINOIS

#### VISION STANDARDS FOR DRIVING

If an individual does not meet these standards, corrective lenses may be prescribed, and the Illinois state eye exam form will reflect this requirement.

#### VISION STANDARDS FOR SCHOOLCHILDREN

CHILDREN MUST PASS VISION SCREENING TO BE ELIGIBLE FOR SCHOOL ENROLLMENT. THE VISION SCREENING FOCUSES ON IDENTIFYING COMMON ISSUES SUCH AS AMBLYOPIA (LAZY EYE), STRABISMUS (CROSSED EYES), AND REFRACTIVE ERRORS. IF THE ILLINOIS STATE EYE EXAM FORM INDICATES VISION PROBLEMS, FURTHER EVALUATION OR TREATMENT MAY BE RECOMMENDED BEFORE OR DURING THE SCHOOL YEAR.

# SUBMISSION AND COMPLIANCE FOR SCHOOLS AND DMV

Proper submission of the Illinois state eye exam form is necessary to satisfy school and Department of Motor Vehicles (DMV) requirements. Compliance helps avoid administrative complications and ensures that individuals meet all health and safety regulations.

#### SUBMITTING THE FORM TO SCHOOLS

PARENTS OR GUARDIANS MUST PROVIDE THE COMPLETED ILLINOIS STATE EYE EXAM FORM TO THE CHILD'S SCHOOL BY THE DESIGNATED DEADLINE, USUALLY BEFORE THE START OF THE ACADEMIC YEAR. #### MAINTAINING COMPLIANCE

#### HOW OFTEN DO I NEED TO SUBMIT AN ILLINOIS STATE EYE EXAM FORM?

THE FREQUENCY VARIES, BUT GENERALLY, DRIVERS MUST SUBMIT THE FORM DURING CERTAIN LICENSE RENEWALS OR IF REQUESTED BY THE ILLINOIS SECRETARY OF STATE DUE TO VISION CONCERNS.

# CAN I USE A REGULAR PRESCRIPTION FROM MY EYE DOCTOR FOR THE ILLINOIS STATE EYE EXAM FORM?

NO, A REGULAR PRESCRIPTION IS NOT SUFFICIENT. THE EYE EXAM MUST SPECIFICALLY ADDRESS THE REQUIREMENTS OUTLINED ON THE ILLINOIS STATE EYE EXAM FORM AND BE COMPLETED BY A LICENSED PROFESSIONAL.

# WHAT HAPPENS IF I FAIL TO SUBMIT THE ILLINOIS STATE EYE EXAM FORM WHEN REQUIRED?

FAILURE TO SUBMIT THE REQUIRED EYE EXAM FORM CAN RESULT IN DELAYS IN LICENSE ISSUANCE OR RENEWAL, AND POTENTIALLY SUSPENSION OF DRIVING PRIVILEGES UNTIL THE REQUIREMENT IS FULFILLED.

## IS THERE A FEE ASSOCIATED WITH THE ILLINOIS STATE EYE EXAM FORM?

THERE IS NO FEE FOR THE FORM ITSELF, BUT FEES MAY APPLY FOR THE EYE EXAM PERFORMED BY THE LICENSED PROFESSIONAL, WHICH VARIES DEPENDING ON THE PROVIDER.
