REGISTERED IMMIGRATION CONSULTANTS AND NOTARIOS

IN CALIFORNIA, IMMIGRATION CONSULTANTS ARE OFTEN REFERRED TO AS NOTARIOS OR NOTARY PUBLICS; HOWEVER, THESE TITLES CAN BE MISLEADING BECAUSE NOTARIES ARE NOT AUTHORIZED TO PROVIDE LEGAL ADVICE UNLESS THEY ARE LICENSED ATTORNEYS. IT IS IMPORTANT TO DISTINGUISH BETWEEN AUTHORIZED IMMIGRATION CONSULTANTS AND UNAUTHORIZED PRACTITIONERS TO AVOID LEGAL PENALTIES.

FEDERAL REGULATIONS AND THE ROLE OF DOJ ACCREDITATION

THE U.S. DEPARTMENT OF JUSTICE (DOJ) OFFERS ACCREDITATION TO NON-ATTORNEY REPRESENTATIVES, INCLUDING IMMIGRATION CONSULTANTS, ALLOWING THEM TO PROVIDE IMMIGRATION SERVICES UNDER CERTAIN CONDITIONS. OBTAINING DOJ ACCREDITATION REQUIRES MEETING SPECIFIC TRAINING AND ETHICAL STANDARDS, WHICH IS A KEY PART OF IMMIGRATION CONSULTANT TRAINING IN CALIFORNIA.
