DPU (Delivered at Place Unloaded)

DPU is unique as the seller is responsible for unloading the goods at the destination, transferring risk after unloading.

DDP (Delivered Duty Paid)

DDP places the maximum obligation on the seller, who must deliver goods ready for unloading at the destination and pay all costs, including import duties and taxes.

Incoterms Specific to Sea and Inland Waterway Transport

FAS (Free Alongside Ship)
