- **ONLINE AND HYBRID CLASSES:** MANY INSTITUTIONS OFFER FLEXIBLE LEARNING OPTIONS TO ACCOMMODATE WORKING PROFESSIONALS.

INSTITUTIONS OFFERING MEDICAL CODING CLASSES

- **CPB (CERTIFIED PROFESSIONAL BILLER):** FOCUSES ON MEDICAL BILLING SKILLS COMPLEMENTARY TO CODING.

PROGRAM ACCREDITATION
