ICD Codes

THE CURRENT VERSION USED IN THE UNITED STATES IS ICD-10-CM, WHICH PROVIDES DETAILED CODES FOR DIAGNOSES AND REASONS FOR HEALTHCARE ENCOUNTERS.

CPT Codes

THE CURRENT PROCEDURAL TERMINOLOGY (CPT) CODES DESCRIBE MEDICAL, SURGICAL, AND DIAGNOSTIC SERVICES.

MAINTAINED BY THE AMERICAN MEDICAL ASSOCIATION, CPT CODES ARE ESSENTIAL FOR DOCUMENTING THE PROCEDURES AND SERVICES PERFORMED DURING A PATIENT ENCOUNTER. THESE CODES HELP DETERMINE REIMBURSEMENT LEVELS.

HCPCS Codes

THE HEALTHCARE COMMON PROCEDURE CODING SYSTEM (HCPCS) IS USED PRIMARILY TO IDENTIFY PRODUCTS, SUPPLIES, AND SERVICES NOT INCLUDED IN CPT CODES, SUCH AS AMBULANCE SERVICES AND DURABLE MEDICAL EQUIPMENT. HCPCS LEVEL II CODES SUPPLEMENT CPT CODES TO PROVIDE A COMPLETE BILLING PICTURE.
