FOUNDATIONS OF MEDICAL SOCIOLOGY

THE "SICK ROLE," INTRODUCED BY PARSONS, EXEMPLIFIES THIS PERSPECTIVE, DEFINING EXPECTED BEHAVIORS OF THE SICK AND SOCIETY'S RESPONSE.

CONFLICT THEORY

CONFLICT THEORY EMPHASIZES POWER STRUGGLES AND INEQUALITIES IN HEALTHCARE ACCESS AND OUTCOMES. IT CRITIQUES HOW SOCIAL STRATIFICATION, ECONOMIC DISPARITIES, AND INSTITUTIONAL BIASES CREATE HEALTH INEQUITIES. THIS PERSPECTIVE HIGHLIGHTS THE ROLE OF CAPITALISM AND CLASS CONFLICT IN DETERMINING WHO RECEIVES ADEQUATE CARE.

SYMBOLIC INTERACTIONISM

SOCIAL DETERMINANTS OF HEALTH AND ILLNESS

SOCIAL DETERMINANTS OF HEALTH ARE THE CONDITIONS IN WHICH PEOPLE ARE BORN, GROW, LIVE, WORK, AND AGE THAT AFFECT HEALTH OUTCOMES. THESE FACTORS ARE CRITICAL IN MEDICAL SOCIOLOGY EXAM 1 AS THEY EXPLAIN DISPARITIES AND PATTERNS IN DISEASE PREVALENCE AND WELLNESS.

ECONOMIC STATUS AND HEALTH

RACIAL AND ETHNIC MINORITIES OFTEN FACE SYSTEMIC BARRIERS TO HEALTHCARE AND EXPERIENCE WORSE HEALTH OUTCOMES. DISCRIMINATION, CULTURAL DIFFERENCES, AND UNEQUAL TREATMENT CONTRIBUTE TO PERSISTENT DISPARITIES ACROSS VARIOUS HEALTH INDICATORS.

ENVIRONMENTAL AND OCCUPATIONAL FACTORS

LIVING IN POLLUTED OR HAZARDOUS ENVIRONMENTS AND ENGAGING IN RISKY OCCUPATIONS CAN INCREASE EXPOSURE TO HEALTH RISKS. ENVIRONMENTAL JUSTICE CONCERNS ADDRESS HOW MARGINALIZED COMMUNITIES DISPROPORTIONATELY BEAR THESE BURDENS.

HEALTHCARE SYSTEMS AND SOCIAL INSTITUTIONS

THE SOCIOLOGY OF ILLNESS AND HEALTH BEHAVIOR

THIS SECTION EXPLORES HOW ILLNESS IS EXPERIENCED, INTERPRETED, AND MANAGED WITHIN SOCIAL CONTEXTS. IT ALSO ADDRESSES HEALTH BEHAVIORS THAT CONTRIBUTE TO WELLNESS OR DISEASE, HIGHLIGHTING THE IMPORTANCE OF CULTURAL AND SOCIAL INFLUENCES.

ILLNESS EXPERIENCE AND IDENTITY

HEALTH-SEEKING BEHAVIOR

DECISIONS REGARDING WHEN AND HOW TO SEEK MEDICAL CARE ARE INFLUENCED BY CULTURAL BELIEFS, SOCIAL NORMS, AND ACCESS BARRIERS. UNDERSTANDING THESE BEHAVIORS IS CRUCIAL FOR IMPROVING HEALTHCARE UTILIZATION AND OUTCOMES.

STIGMA AND CHRONIC ILLNESS
