PASSING THE EXAM DEMONSTRATES THAT A CANDIDATE HAS MASTERED ESSENTIAL MEDICATION ADMINISTRATION PROTOCOLS, UNDERSTANDS LEGAL RESPONSIBILITIES, AND CAN PERFORM DUTIES SAFELY AND EFFECTIVELY.

PURPOSE AND IMPORTANCE OF THE EXAM

REGULATORY AUTHORITY

PROGRAMS ALSO REQUIRE SUPERVISED CLINICAL PRACTICE TO PROVIDE HANDS-ON EXPERIENCE. ONLY GRADUATES OF ACCREDITED PROGRAMS ARE ELIGIBLE TO SIT FOR THE MEDICATION AIDE STATE EXAM TEXAS.

EXAM CONTENT AND FORMAT

OBTAINING CERTIFICATION

CONTINUING EDUCATION AND RECERTIFICATION

CONTINUING EDUCATION REQUIREMENTS
