THESE REQUIREMENTS IMPACT HOW PHYSICAL THERAPY SERVICES ARE PRESCRIBED, DOCUMENTED, AND BILLED UNDER MEDICARE PART B. OVERVIEW OF MEDICARE REFERRAL REQUIREMENTS FOR PHYSICAL THERAPY

MEDICARE REFERRAL REQUIREMENTS FOR PHYSICAL THERAPY ARE DESIGNED TO REGULATE ACCESS TO THERAPEUTIC SERVICES AND CONFIRM MEDICAL NECESSITY. FOR PHYSICAL THERAPY SERVICES TO BE COVERED UNDER MEDICARE PART B, A REFERRAL OR ORDER FROM A QUALIFIED HEALTHCARE PROVIDER IS TYPICALLY REQUIRED. THIS REFERRAL SERVES AS FORMAL AUTHORIZATION FOR THE PHYSICAL THERAPIST TO BEGIN TREATMENT AND IS PART OF MEDICARE'S EFFORT TO ENSURE THAT SERVICES PROVIDED ARE REASONABLE, NECESSARY, AND PROPERLY DOCUMENTED. THE REFERRAL PROCESS INCLUDES INITIAL EVALUATION, TREATMENT PLANNING, AND ONGOING CERTIFICATION TO VERIFY CONTINUED NEED FOR THERAPY.

Physical therapy referrals are subject to specific timelines and documentation standards. Failure to meet these requirements can result in claim denials or delayed payments. Therefore, both referring providers and physical therapists must be familiar with Medicare's regulations to ensure compliance. This section sets the foundation by explaining the general principles behind Medicare's referral mandates for physical therapy services.

WHO CAN PROVIDE A REFERRAL FOR PHYSICAL THERAPY

MEDICARE REQUIRES THAT PHYSICAL THERAPY REFERRALS COME FROM CERTAIN QUALIFIED HEALTHCARE PROFESSIONALS. UNDERSTANDING WHO IS AUTHORIZED TO PROVIDE THESE REFERRALS IS CRUCIAL FOR BOTH PATIENTS AND PROVIDERS.

QUALIFIED REFERRING PROVIDERS

ACCORDING TO MEDICARE GUIDELINES, REFERRALS FOR PHYSICAL THERAPY MUST BE MADE BY ONE OF THE FOLLOWING PRACTITIONERS:

• Physicians (MD or DO)

- Physician assistants (PAs)
- CERTIFIED NURSE PRACTITIONERS (NPs)
- CLINICAL NURSE SPECIALISTS (CNSs)
- OTHER QUALIFIED NON-PHYSICIAN PRACTITIONERS AS RECOGNIZED BY MEDICARE

These providers must have an established relationship with the patient and be authorized under state law to order physical therapy services. The referral or order must be dated and signed by the referring provider prior to the initiation of therapy.

ROLE OF THE PHYSICAL THERAPIST

While physical therapists do not provide referrals themselves, they are responsible for ensuring that a valid referral or order is on file before starting treatment. They must also maintain documentation supporting the medical necessity of ongoing therapy throughout the treatment period.

DOCUMENTATION AND CERTIFICATION GUIDELINES

PROPER DOCUMENTATION IS A CORNERSTONE OF MEDICARE REFERRAL REQUIREMENTS FOR PHYSICAL THERAPY. MEDICARE MANDATES SPECIFIC FORMS AND CERTIFICATIONS TO VERIFY THAT THERAPY SERVICES MEET COVERAGE CRITERIA.

INITIAL CERTIFICATION AND PLAN OF CARE

Before physical therapy services begin, the referring provider must certify the patient's need for therapy and establish a plan of care. This certification includes:

- DIAGNOSIS SUPPORTING THE NEED FOR PHYSICAL THERAPY
- Type, amount, frequency, and duration of therapy services
- GOALS AND EXPECTED OUTCOMES OF THERAPY

The plan of care must be signed and dated by the referring provider and provided to the physical therapist within 30 days of the first treatment date.

RECERTIFICATION REQUIREMENTS

For ongoing therapy beyond the initial certification period, Medicare requires periodic recertification by the referring provider. This entails reviewing the patient's progress and updating the plan of care to reflect changes in treatment strategy or goals. Typically, recertification occurs every 90 days or sooner if the patient's condition changes significantly.

MEDICARE COVERAGE CRITERIA FOR PHYSICAL THERAPY

MEDICARE COVERS PHYSICAL THERAPY SERVICES ONLY WHEN THEY ARE DEEMED MEDICALLY NECESSARY AND REASONABLE FOR THE DIAGNOSIS OR TREATMENT OF A CONDITION. UNDERSTANDING THESE COVERAGE CRITERIA HELPS CLARIFY THE REFERRAL REQUIREMENTS.

MEDICAL NECESSITY

MEDICARE DEFINES MEDICAL NECESSITY FOR PHYSICAL THERAPY AS SERVICES THAT ARE REQUIRED TO IMPROVE OR MAINTAIN FUNCTION, PREVENT OR SLOW DETERIORATION, OR ASSIST WITH REHABILITATION FOLLOWING AN INJURY OR ILLNESS. THERAPY MUST BE PROVIDED IN A SKILLED SETTING AND PERFORMED BY QUALIFIED PERSONNEL.

COVERED SERVICES

COVERED PHYSICAL THERAPY SERVICES UNDER MEDICARE INCLUDE:

- THERAPEUTIC EXERCISES TO IMPROVE STRENGTH, ENDURANCE, AND FLEXIBILITY
- MANUAL THERAPY TECHNIQUES
- GAIT TRAINING AND BALANCE ACTIVITIES
- Use of therapeutic modalities such as ultrasound, electrical stimulation, or heat

SERVICES NOT MEETING COVERAGE GUIDELINES OR LACKING PROPER REFERRAL DOCUMENTATION MAY BE DENIED.

BILLING AND COMPLIANCE CONSIDERATIONS

COMPLIANCE WITH MEDICARE REFERRAL REQUIREMENTS FOR PHYSICAL THERAPY EXTENDS TO ACCURATE BILLING AND CLAIMS SUBMISSION. PROVIDERS MUST BE DILIGENT IN ADHERING TO CODING, DOCUMENTATION, AND AUTHORIZATION RULES.

CLAIMS SUBMISSION REQUIREMENTS

WHEN SUBMITTING CLAIMS FOR PHYSICAL THERAPY SERVICES, PROVIDERS MUST INCLUDE:

- Valid referral or order documentation
- CERTIFICATION AND RECERTIFICATION DETAILS
- ACCURATE CODING REFLECTING THE SERVICES PROVIDED
- SUPPORTING CLINICAL NOTES DEMONSTRATING MEDICAL NECESSITY

CLAIMS LACKING THIS INFORMATION ARE AT RISK FOR DENIAL OR AUDIT.

AUDIT AND PENALTY RISKS

IMPROPER OR MISSING REFERRALS CAN TRIGGER MEDICARE AUDITS, LEADING TO POTENTIAL REPAYMENT DEMANDS OR PENALTIES.

PROVIDERS SHOULD MAINTAIN THOROUGH RECORDS AND ENSURE ALL REFERRAL REQUIREMENTS ARE MET TO MINIMIZE COMPLIANCE RISKS.

COMMON QUESTIONS ABOUT MEDICARE PHYSICAL THERAPY REFERRALS

SEVERAL FREQUENTLY ASKED QUESTIONS ARISE REGARDING MEDICARE REFERRAL REQUIREMENTS FOR PHYSICAL THERAPY.

IS A NEW REFERRAL REQUIRED FOR EACH EPISODE OF CARE?

NO, MEDICARE ALLOWS A SINGLE REFERRAL AND CERTIFICATION TO COVER AN EPISODE OF CARE, TYPICALLY LASTING UP TO 90 DAYS, WITH REQUIRED RECERTIFICATIONS THEREAFTER IF THERAPY CONTINUES. HOWEVER, NEW REFERRALS ARE NEEDED IF THE PATIENT'S CONDITION CHANGES OR IF THERAPY IS RESTARTED AFTER AN EXTENDED BREAK.

CAN TELEHEALTH PHYSICAL THERAPY SERVICES BE REFERRED UNDER MEDICARE?

MEDICARE HAS EXPANDED COVERAGE FOR TELEHEALTH IN CERTAIN SITUATIONS, BUT REFERRAL REQUIREMENTS REMAIN. THE ORDERING PROVIDER MUST STILL ISSUE A VALID REFERRAL OR ORDER, AND SERVICES MUST MEET MEDICAL NECESSITY CRITERIA TO BE COVERED.

WHAT HAPPENS IF A REFERRAL IS MISSING OR INVALID?

CLAIMS SUBMITTED WITHOUT A VALID REFERRAL OR CERTIFICATION WILL LIKELY BE DENIED PAYMENT. PROVIDERS MAY NEED TO OBTAIN RETROSPECTIVE DOCUMENTATION OR APPEAL DENIALS, BUT PREVENTION THROUGH PROPER REFERRAL MANAGEMENT IS PREFERABLE.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE MEDICARE REFERRAL REQUIREMENTS FOR PHYSICAL THERAPY SERVICES?

MEDICARE REQUIRES A SIGNED PLAN OF CARE FROM A PHYSICIAN OR QUALIFIED NON-PHYSICIAN PRACTITIONER BEFORE INITIATING OUTPATIENT PHYSICAL THERAPY SERVICES. THE PLAN MUST INCLUDE DIAGNOSIS, ANTICIPATED GOALS, TREATMENT PLAN, AND FREQUENCY/DURATION OF THERAPY.

DOES MEDICARE REQUIRE A FORMAL REFERRAL FOR PHYSICAL THERAPY?

MEDICARE DOES NOT REQUIRE A FORMAL REFERRAL BUT DOES REQUIRE A WRITTEN PLAN OF CARE SIGNED BY A PHYSICIAN OR QUALIFIED NON-PHYSICIAN PRACTITIONER TO CERTIFY THE MEDICAL NECESSITY OF PHYSICAL THERAPY SERVICES.

WHO CAN PROVIDE THE REFERRAL OR PLAN OF CARE FOR MEDICARE PHYSICAL THERAPY?

A PHYSICIAN (MD OR DO) OR A QUALIFIED NON-PHYSICIAN PRACTITIONER SUCH AS A NURSE PRACTITIONER OR PHYSICIAN ASSISTANT CAN PROVIDE AND SIGN THE PLAN OF CARE FOR MEDICARE PHYSICAL THERAPY SERVICES.

HOW OFTEN MUST THE MEDICARE PLAN OF CARE FOR PHYSICAL THERAPY BE REVIEWED OR UPDATED?

THE PLAN OF CARE MUST BE REVIEWED AND RECERTIFIED BY THE REFERRING PROVIDER AT LEAST EVERY 90 DAYS OR MORE FREQUENTLY IF THE PATIENT'S CONDITION CHANGES OR THERAPY GOALS ARE UPDATED.

ARE THERE ANY DOCUMENTATION REQUIREMENTS FOR MEDICARE PHYSICAL THERAPY REFERRALS?

YES, DOCUMENTATION MUST INCLUDE THE SIGNED PLAN OF CARE WITH DIAGNOSIS, TREATMENT GOALS, THERAPY MODALITIES, FREQUENCY, AND DURATION. THIS DOCUMENTATION MUST BE MAINTAINED AND AVAILABLE FOR MEDICARE AUDITS.

CAN PHYSICAL THERAPISTS INITIATE MEDICARE PHYSICAL THERAPY WITHOUT A REFERRAL?

Physical therapists can perform an initial evaluation but must have a signed plan of care from a physician or qualified non-physician practitioner before continuing treatment under Medicare.

IS A REFERRAL NEEDED FOR ALL TYPES OF PHYSICAL THERAPY COVERED BY MEDICARE?

YES, FOR MEDICARE COVERAGE, ALL OUTPATIENT PHYSICAL THERAPY SERVICES REQUIRE A SIGNED PLAN OF CARE FROM AN AUTHORIZED PROVIDER CERTIFYING MEDICAL NECESSITY.

WHAT HAPPENS IF MEDICARE PHYSICAL THERAPY SERVICES ARE PROVIDED WITHOUT A PROPER REFERRAL OR PLAN OF CARE?

WITHOUT A VALID PLAN OF CARE SIGNED BY AN AUTHORIZED PROVIDER, MEDICARE MAY DENY PAYMENT FOR PHYSICAL THERAPY SERVICES, AND PROVIDERS MAY BE REQUIRED TO REFUND PAYMENTS OR FACE COMPLIANCE ISSUES.
