THE INFLUX OF MIGRANTS CAN CHANGE VOTER BASES, INFLUENCE ELECTION OUTCOMES, AND PROMPT POLITICAL PARTIES TO ADJUST THEIR PLATFORMS TO APPEAL TO DIVERSE POPULATIONS. THESE DEMOGRAPHIC SHIFTS OFTEN LEAD TO DEBATES ABOUT CITIZENSHIP, VOTING RIGHTS, AND POLITICAL INCLUSION.

CHANGING VOTER DEMOGRAPHICS

AS MIGRANTS SETTLE AND NATURALIZE, THEY BECOME PART OF THE ELECTORATE, CONTRIBUTING TO SHIFTS IN VOTER DEMOGRAPHICS. CHALLENGES OF SOCIAL COHESION
