Among other things, the various client African states provided the U.S. with access to airfields, deep water ports and sites for the establishment of various intelligence gathering facilities. In this vein, the U.S. undertook various military-security initiatives. The fourth cycle began after the 9/11 terrorist attacks against the American homeland. Since then, the U.S. has expanded the scope of its security relations with Africa, as reflected in the establishment of various initiatives and programs.

At the core is the prosecution of the American war on terror. Against this backdrop, this book examines some of the major dimensions of the U.S.' security relations with Africa, including American security interests on the continent, the war on terror, AFRICOM, and military cooperation.
