TYPICALLY, A POLITICAL PHILOSOPHY MASTERS DEGREE LASTS ONE TO TWO YEARS, DEPENDING ON THE INSTITUTION AND WHETHER THE STUDENT STUDIES FULL-TIME OR PART-TIME. CORE CURRICULUM AND KEY SUBJECTS
