Locals hardly knew whom to trust as Unionists and Confederates—from both home and afar—engaged in guerilla warfare, stole resources from citizens, and made the war a confusing trap rather than a struggle for an emergent nation. Drawing on the primary source record of newspapers, letters, diaries, and official documents from the county, Hébert compellingly works personalized vignettes into a scholarly study of developments from the advent of war through Reconstruction and the decades following. The Long Civil War in the North Georgia Mountains solidifies recent scholarship about the war in southern Appalachia and opens a window into a community deeply divided by civil war. KEITH S. HÉBERT, assistant professor of history at Auburn University, was formerly state historian at the Georgia Department of Natural Resources, Historic Preservation Division.
