ETHICAL GUIDELINES

AGENCIES MUST ENSURE THAT POLYGRAPH EXAMS RESPECT CANDIDATES' RIGHTS AND THAT RESULTS ARE NOT USED TO UNFAIRLY DISCRIMINATE OR TERMINATE EMPLOYMENT WITHOUT CORROBORATING EVIDENCE.
