UNDERSTANDING PREGNANCY TEST SERUM CPT CODE

THE CPT SYSTEM, MAINTAINED BY THE AMERICAN MEDICAL ASSOCIATION (AMA), PROVIDES SPECIFIC CODES FOR PROCEDURES AND SERVICES, INCLUDING LABORATORY TESTS. USING THE CORRECT PREGNANCY TEST SERUM CPT CODE ENSURES THAT THE HEALTHCARE PROVIDER'S SERVICES ARE ACCURATELY RECORDED AND REIMBURSED.

WHAT IS THE CPT CODE FOR SERUM PREGNANCY TEST?

THE CPT CODE MOST COMMONLY USED FOR THE SERUM PREGNANCY TEST IS **84703**. URINE PREGNANCY TESTS

URINE PREGNANCY TESTS DETECT HCG IN THE URINE AND ARE OFTEN USED FOR RAPID, POINT-OF-CARE SCREENING. THE CORRESPONDING CPT CODES FOR URINE PREGNANCY TESTS ARE:

- **81025:** URINE PREGNANCY TEST, BY VISUAL COLOR COMPARISON METHODS (E.G., DIPSTICK).
- **81025 WITH MODIFIER:** SOMETIMES USED WITH MODIFIERS TO INDICATE SPECIFIC CIRCUMSTANCES OR SETTINGS.

IT IS IMPORTANT NOT TO CONFUSE THE URINE PREGNANCY TEST CODE WITH THE SERUM TEST CODE, AS THEY REPRESENT DIFFERENT TESTING METHODOLOGIES AND REIMBURSEMENT RATES.

BILLING AND DOCUMENTATION GUIDELINES
