PREMIUM PROCESSING 15 BUSINESS DAYS IS A SERVICE OFFERED BY THE U.S. CITIZENSHIP AND IMMIGRATION SERVICES (USCIS) TO EXPEDITE THE PROCESSING OF CERTAIN IMMIGRATION PETITIONS AND APPLICATIONS. THIS EXPEDITED SERVICE GUARANTEES THAT USCIS WILL PROCESS THE PETITION WITHIN 15 BUSINESS DAYS, SIGNIFICANTLY REDUCING THE WAITING PERIOD COMPARED TO REGULAR PROCESSING TIMES. THE PREMIUM PROCESSING OPTION IS PARTICULARLY VALUABLE FOR EMPLOYERS AND APPLICANTS SEEKING FASTER ADJUDICATION OF VISA PETITIONS SUCH AS H-1B, L-1, AND OTHERS. UNDERSTANDING THE ELIGIBILITY CRITERIA, APPLICATION PROCESS, ASSOCIATED FEES, AND POTENTIAL BENEFITS OF PREMIUM PROCESSING 15 BUSINESS DAYS IS ESSENTIAL FOR MAKING INFORMED DECISIONS REGARDING IMMIGRATION CASES. WHAT IS PREMIUM PROCESSING?

PREMIUM PROCESSING IS A SERVICE PROVIDED BY USCIS THAT ALLOWS PETITIONERS TO REQUEST FASTER ADJUDICATION OF CERTAIN IMMIGRATION PETITIONS AND APPLICATIONS. BY PAYING AN ADDITIONAL FEE, PETITIONERS RECEIVE A GUARANTEED PROCESSING TIME OF 15 BUSINESS DAYS, AFTER WHICH USCIS WILL EITHER APPROVE, DENY, OR ISSUE A REQUEST FOR EVIDENCE (RFE). THIS SERVICE IS DESIGNED TO EXPEDITE THE HANDLING OF TIME-SENSITIVE CASES AND PROVIDE GREATER CERTAINTY REGARDING THE STATUS OF A PETITION. THE PREMIUM PROCESSING 15 BUSINESS DAYS RULE MEANS THAT USCIS COMMITS TO COMPLETING THE REVIEW WITHIN THAT TIMEFRAME, SIGNIFICANTLY SHORTENING THE OVERALL PROCESSING PERIOD COMPARED TO STANDARD PROCESSING TIMES THAT CAN TAKE SEVERAL MONTHS.

SCOPE AND PURPOSE

THE PRIMARY PURPOSE OF PREMIUM PROCESSING IS TO FACILITATE QUICKER DECISION-MAKING FOR CERTAIN EMPLOYMENT-BASED PETITIONS AND APPLICATIONS. THIS SERVICE IS BENEFICIAL TO EMPLOYERS WHO WANT TO SECURE WORK AUTHORIZATION FOR FOREIGN EMPLOYEES PROMPTLY OR INDIVIDUALS WHO NEED EXPEDITED ADJUDICATION OF THEIR IMMIGRATION BENEFITS. THE 15-BUSINESS-DAY TIMEFRAME APPLIES TO SPECIFIC CATEGORIES OF PETITIONS AND IS NOT AVAILABLE FOR ALL IMMIGRATION FORMS.

TYPES OF PETITIONS ELIGIBLE

PREMIUM PROCESSING IS GENERALLY AVAILABLE FOR VARIOUS EMPLOYMENT-BASED VISA CATEGORIES, INCLUDING BUT NOT LIMITED TO:

- H-1B SPECIALTY OCCUPATIONS
- L-1 INTRACOMPANY TRANSFEREE
- O-1 INDIVIDUALS WITH EXTRAORDINARY ABILITY
- EB-1 AND EB-2 EMPLOYMENT-BASED IMMIGRANT PETITIONS
- CERTAIN PETITIONS FOR WORKERS IN THE ARTS, SCIENCES, AND EDUCATION SECTORS

IT IS IMPORTANT TO VERIFY CURRENT ELIGIBILITY AS USCIS PERIODICALLY UPDATES THE LIST OF FORMS ELIGIBLE FOR PREMIUM PROCESSING.

ELIGIBILITY FOR PREMIUM PROCESSING 15 BUSINESS DAYS

NOT ALL IMMIGRATION PETITIONS QUALIFY FOR PREMIUM PROCESSING 15 BUSINESS DAYS. ELIGIBILITY DEPENDS ON THE TYPE OF FORM FILED, THE PETITIONER'S STATUS, AND THE AVAILABILITY OF THE SERVICE AT THE TIME OF APPLICATION. USCIS MAINTAINS A LIST OF FORMS ELIGIBLE FOR PREMIUM PROCESSING, WHICH CAN CHANGE PERIODICALLY BASED ON POLICY UPDATES AND WORKLOAD CONSIDERATIONS.

PETITION CATEGORIES

THE FOLLOWING PETITION CATEGORIES ARE COMMONLY ELIGIBLE FOR PREMIUM PROCESSING:

- FORM I-129: PETITION FOR A NONIMMIGRANT WORKER (INCLUDING H-1B, L-1, O-1 CATEGORIES)
- FORM I-140: IMMIGRANT PETITION FOR ALIEN WORKER (CERTAIN EMPLOYMENT-BASED GREEN CARD CATEGORIES)
- FORM I-907: REQUEST FOR PREMIUM PROCESSING SERVICE (USED TO REQUEST PREMIUM PROCESSING FOR ELIGIBLE PETITIONS)

RESTRICTIONS AND EXCEPTIONS

SOME PETITIONS ARE EXCLUDED FROM PREMIUM PROCESSING DUE TO STATUTORY OR REGULATORY RESTRICTIONS. FOR EXAMPLE, PETITIONS BASED ON ASYLUM, REFUGEE STATUS, OR CERTAIN FAMILY-BASED IMMIGRATION CATEGORIES ARE GENERALLY INELIGIBLE. ADDITIONALLY, PREMIUM PROCESSING MAY BE TEMPORARILY SUSPENDED FOR SOME PETITION TYPES DURING HIGH-DEMAND PERIODS OR CHANGES IN IMMIGRATION POLICY.

HOW TO APPLY FOR PREMIUM PROCESSING

APPLYING FOR PREMIUM PROCESSING 15 BUSINESS DAYS INVOLVES SUBMITTING A SPECIFIC REQUEST ALONG WITH THE INITIAL PETITION OR AS A SEPARATE SERVICE REQUEST. THE PROCESS REQUIRES CAREFUL ATTENTION TO USCIS GUIDELINES TO ENSURE PROPER FILING AND AVOID DELAYS.

FILING FORM I-907

THE OFFICIAL FORM TO REQUEST PREMIUM PROCESSING IS FORM I-907, REQUEST FOR PREMIUM PROCESSING SERVICE. PETITIONERS CAN FILE FORM I-907 CONCURRENTLY WITH THE UNDERLYING PETITION OR AS AN ADD-ON AFTER THE PETITION HAS

BEEN FILED AND IS PENDING ADJUDICATION.

REQUIRED FEES

THE PREMIUM PROCESSING SERVICE REQUIRES THE PAYMENT OF AN ADDITIONAL FEE, WHICH IS SEPARATE FROM THE STANDARD PETITION FILING FEE. THIS FEE IS SUBJECT TO CHANGE AND MUST BE PAID BY CHECK, MONEY ORDER, OR CREDIT CARD USING THE APPROPRIATE USCIS PAYMENT METHODS.

SUBMISSION GUIDELINES

WHEN SUBMITTING A PREMIUM PROCESSING REQUEST, IT IS ESSENTIAL TO:

- COMPLETE FORM I-907 ACCURATELY AND COMPLETELY
- INCLUDE THE CORRECT FEE PAYMENT
- FILE THE FORMS AT THE APPROPRIATE USCIS SERVICE CENTER ADDRESS SPECIFIED FOR PREMIUM PROCESSING
- ENSURE THE UNDERLYING PETITION IS ELIGIBLE FOR PREMIUM PROCESSING

FAILURE TO COMPLY WITH THESE REQUIREMENTS MAY RESULT IN REJECTION OR DELAYS.

PROCESSING TIMELINE AND WHAT TO EXPECT

THE DEFINING FEATURE OF PREMIUM PROCESSING 15 BUSINESS DAYS IS THE GUARANTEED ADJUDICATION TIMEFRAME. USCIS COMMITS TO PROCESSING THE PETITION WITHIN 15 BUSINESS DAYS FROM THE DATE OF RECEIPT OF THE PREMIUM PROCESSING REQUEST.

DEFINITION OF BUSINESS DAYS

THE 15-BUSINESS-DAY PERIOD EXCLUDES WEEKENDS AND FEDERAL HOLIDAYS, MEANING THE ACTUAL CALENDAR TIME MAY BE SLIGHTLY LONGER DEPENDING ON WHEN THE REQUEST IS RECEIVED. FOR EXAMPLE, A REQUEST RECEIVED ON A FRIDAY WOULD BEGIN COUNTING FROM THE FOLLOWING MONDAY.

USCIS RESPONSE TYPES

WITHIN THE 15-BUSINESS-DAY PERIOD, USCIS WILL ISSUE ONE OF THE FOLLOWING RESPONSES:

- APPROVAL NOTICE
- DENIAL NOTICE
- REQUEST FOR EVIDENCE (RFE) OR NOTICE OF INTENT TO DENY (NOID)

IF AN RFE IS ISSUED, THE 15-BUSINESS-DAY CLOCK PAUSES UNTIL THE PETITIONER RESPONDS WITH THE REQUESTED INFORMATION, AT WHICH POINT THE CLOCK RESTARTS.

BENEFITS OF CHOOSING PREMIUM PROCESSING

PREMIUM PROCESSING 15 BUSINESS DAYS OFFERS SEVERAL ADVANTAGES THAT CAN BE CRITICAL IN TIME-SENSITIVE IMMIGRATION CASES.

FASTER ADJUDICATION

THE MOST OBVIOUS BENEFIT IS THE SIGNIFICANTLY SHORTENED ADJUDICATION TIME COMPARED TO STANDARD PROCESSING, WHICH CAN TAKE SEVERAL MONTHS. THIS ACCELERATION HELPS EMPLOYERS AND APPLICANTS PLAN EMPLOYMENT START DATES AND OTHER LOGISTICAL MATTERS MORE EFFECTIVELY.

PRIORITY SERVICE

PETITIONS FILED WITH PREMIUM PROCESSING RECEIVE PRIORITY HANDLING BY USCIS OFFICERS, ENSURING THAT THESE CASES ARE EXPEDITED WITHIN THE AGENCY'S WORKFLOW.

IMPROVED CERTAINTY AND PLANNING

WITH A GUARANTEED RESPONSE TIME, PETITIONERS GAIN GREATER PREDICTABILITY AND CAN MAKE INFORMED DECISIONS REGARDING TRAVEL, EMPLOYMENT, AND VISA STAMPING PROCESSES.

ABILITY TO UPGRADE

IN SOME CASES, PETITIONERS WHO INITIALLY FILED WITHOUT PREMIUM PROCESSING CAN UPGRADE THEIR PETITION BY SUBMITTING FORM I-907 AND PAYING THE PREMIUM FEE, ENABLING FASTER ADJUDICATION WITHOUT REILING THE ENTIRE PETITION.

LIMITATIONS AND CONSIDERATIONS

DESPITE ITS ADVANTAGES, PREMIUM PROCESSING 15 BUSINESS DAYS HAS CERTAIN LIMITATIONS AND CONSIDERATIONS THAT PETITIONERS SHOULD BE AWARE OF BEFORE OPTING FOR THIS SERVICE.

COST FACTOR

NOT A GUARANTEE OF APPROVAL

WHILE PREMIUM PROCESSING GUARANTEES A FASTER DECISION, IT DOES NOT INFLUENCE THE OUTCOME. PETITIONS CAN STILL BE DENIED OR SUBJECTED TO RFES, WHICH MAY EXTEND THE TOTAL PROCESSING TIME IF ADDITIONAL DOCUMENTATION IS REQUIRED.

TEMPORARY SUSPENSIONS

USCIS MAY TEMPORARILY SUSPEND PREMIUM PROCESSING FOR CERTAIN PETITION TYPES DURING PERIODS OF HIGH DEMAND OR POLICY CHANGES, LIMITING AVAILABILITY TEMPORARILY.

RECENT UPDATES AND CHANGES IN PREMIUM PROCESSING

USCIS PERIODICALLY UPDATES POLICIES AND PROCEDURES RELATED TO PREMIUM PROCESSING 15 BUSINESS DAYS TO REFLECT CHANGES IN IMMIGRATION LAW, ADMINISTRATIVE PRIORITIES, AND OPERATIONAL EFFICIENCY.

FEE ADJUSTMENTS

RECENT ADJUSTMENTS TO PREMIUM PROCESSING FEES REFLECT CHANGES IN ADMINISTRATIVE COSTS AND REGULATORY REQUIREMENTS. PETITIONERS SHOULD VERIFY THE CURRENT FEE SCHEDULE BEFORE SUBMITTING A REQUEST.

EXPANSION OF ELIGIBLE FORMS

USCIS HAS EXPANDED PREMIUM PROCESSING ELIGIBILITY OVER TIME TO INCLUDE ADDITIONAL PETITION CATEGORIES, IMPROVING ACCESS TO EXPEDITED PROCESSING FOR A BROADER RANGE OF APPLICANTS.

PROCESSING DELAYS AND BACKLOGS

ALTHOUGH PREMIUM PROCESSING GUARANTEES A 15-BUSINESS-DAY RESPONSE, EXTERNAL FACTORS SUCH AS STAFFING SHORTAGES OR SUDDEN INCREASES IN PETITION VOLUME CAN IMPACT SERVICE DELIVERY. USCIS COMMUNICATES ANY SUCH DELAYS VIA OFFICIAL NOTICES.

FREQUENTLY ASKED QUESTIONS

WHAT IS PREMIUM PROCESSING WITH A 15 BUSINESS DAY TIMEFRAME?

PREMIUM PROCESSING IS AN EXPEDITED SERVICE OFFERED BY USCIS THAT GUARANTEES PROCESSING OF CERTAIN IMMIGRATION PETITIONS WITHIN 15 BUSINESS DAYS FOR AN ADDITIONAL FEE.

WHICH USCIS FORMS ARE ELIGIBLE FOR PREMIUM PROCESSING WITH A 15 BUSINESS DAY GUARANTEE?

FORMS SUCH AS I-129 (PETITION FOR A NONIMMIGRANT WORKER) AND I-140 (IMMIGRANT PETITION FOR ALIEN WORKER) ARE COMMONLY ELIGIBLE FOR PREMIUM PROCESSING WITH THE 15 BUSINESS DAY TIMEFRAME.

HOW MUCH DOES PREMIUM PROCESSING WITH 15 BUSINESS DAYS COST?

THE FEE FOR PREMIUM PROCESSING IS SUBJECT TO CHANGE, BUT AS OF RECENT UPDATES, IT IS \$2,500 USD. IT IS ADVISABLE TO CHECK THE USCIS WEBSITE FOR THE LATEST FEE INFORMATION.

WHAT HAPPENS IF USCIS DOES NOT PROCESS THE PETITION WITHIN 15 BUSINESS DAYS UNDER PREMIUM PROCESSING?

IF USCIS FAILS TO PROCESS THE PETITION WITHIN 15 BUSINESS DAYS, THE PREMIUM PROCESSING FEE WILL BE REFUNDED, BUT THE PETITION PROCESSING WILL CONTINUE UNDER NORMAL TIMELINES.

CAN PREMIUM PROCESSING BE REQUESTED AFTER SUBMITTING THE INITIAL PETITION?

YES, PETITIONERS CAN FILE FORM I-907 TO REQUEST PREMIUM PROCESSING EVEN AFTER THE INITIAL PETITION HAS BEEN

SUBMITTED, PROVIDED THE PETITION IS ELIGIBLE FOR THE SERVICE.

ARE THERE ANY PETITIONS EXCLUDED FROM PREMIUM PROCESSING WITH THE 15 BUSINESS DAY SERVICE?

YES, SOME PETITIONS SUCH AS CERTAIN EMPLOYMENT-BASED GREEN CARD CATEGORIES OR SPECIFIC TYPES OF ASYLUM APPLICATIONS MAY NOT BE ELIGIBLE FOR PREMIUM PROCESSING.

DOES PREMIUM PROCESSING GUARANTEE PETITION APPROVAL WITHIN 15 BUSINESS DAYS?

NO, PREMIUM PROCESSING GUARANTEES A RESPONSE WITHIN 15 BUSINESS DAYS, WHICH COULD BE AN APPROVAL, DENIAL, OR REQUEST FOR ADDITIONAL EVIDENCE (RFE), BUT NOT NECESSARILY AN APPROVAL.

HOW ARE THE 15 BUSINESS DAYS CALCULATED IN PREMIUM PROCESSING?

THE 15 BUSINESS DAYS REFER TO USCIS WORKING DAYS AND EXCLUDE WEEKENDS AND FEDERAL HOLIDAYS FROM THE DATE USCIS RECEIVES THE PREMIUM PROCESSING REQUEST.

CAN PREMIUM PROCESSING REDUCE THE OVERALL WAIT TIME FOR VISA OR GREEN CARD PROCESSING?
