THE PROGRAM EMPHASIZES A HOLISTIC APPROACH TO PATIENT CARE, ADDRESSING PHYSICAL, EMOTIONAL, AND SOCIAL DETERMINANTS OF HEALTH. RESIDENTS RECEIVE COMPREHENSIVE TRAINING THAT INCLUDES PREVENTIVE CARE, CHRONIC DISEASE MANAGEMENT, AND ACUTE CARE ACROSS ALL AGE GROUPS. CLINICAL ROTATIONS AND PATIENT CARE

CLINICAL ROTATIONS FORM THE CORNERSTONE OF THE SUTTER FAMILY MEDICINE RESIDENCY, PROVIDING RESIDENTS WITH EXPOSURE TO A WIDE ARRAY OF MEDICAL CONDITIONS AND PATIENT POPULATIONS. THE PROGRAM ENSURES THAT RESIDENTS GAIN EXPERIENCE IN BOTH INPATIENT AND OUTPATIENT SETTINGS.

PRIMARY CARE AND AMBULATORY CLINICS

RESIDENTS SPEND SIGNIFICANT TIME IN AMBULATORY CARE CLINICS WHERE THEY MANAGE PATIENTS WITH ACUTE AND CHRONIC ILLNESSES. THESE CLINICS EMPHASIZE CONTINUITY OF CARE, ALLOWING RESIDENTS TO DEVELOP LONG-TERM RELATIONSHIPS WITH PATIENTS AND FAMILIES. THE AMBULATORY EXPERIENCE ENHANCES SKILLS IN PREVENTIVE MEDICINE, HEALTH MAINTENANCE, AND PATIENT EDUCATION.

HOSPITAL AND SPECIALTY ROTATIONS

INPATIENT ROTATIONS INCLUDE TIME IN GENERAL MEDICINE WARDS, EMERGENCY DEPARTMENTS, AND OBSTETRICS UNITS. RESEARCH AND COMMUNITY INVOLVEMENT

- USMLE OR COMLEX SCORES
- MEDICAL SCHOOL TRANSCRIPTS

SELECTED CANDIDATES ARE INVITED FOR INTERVIEWS, WHICH ASSESS INTERPERSONAL SKILLS, CLINICAL JUDGMENT, AND ALIGNMENT WITH THE PROGRAM'S MISSION. THE RESIDENCY VALUES DIVERSITY AND SEEKS RESIDENTS WHO ARE COMMITTED TO SERVING VARIED PATIENT POPULATIONS.
