MEDICAL LEAVE

THIS TYPE OF LEAVE MAY BE SHORT-TERM OR EXTENDED DEPENDING ON THE SEVERITY OF THE HEALTH ISSUE. PERSONAL LEAVE

Personal leave allows teachers to take time off for reasons unrelated to health or family emergencies. This can include attending to personal matters, mental health days, or other non-work-related needs. Schools typically limit the amount of personal leave available and may require advance notice.

FAMILY AND PARENTAL LEAVE

FAMILY AND PARENTAL LEAVE ENABLES TEACHERS TO CARE FOR NEWBORNS, NEWLY ADOPTED CHILDREN, OR SICK FAMILY

MEMBERS. THIS LEAVE IS OFTEN PROTECTED BY FEDERAL LAWS SUCH AS FMLA, WHICH PROVIDES ELIGIBLE EMPLOYEES UP TO 12 WEEKS OF UNPAID LEAVE FOR QUALIFYING FAMILY REASONS.

PROFESSIONAL DEVELOPMENT LEAVE

Professional development leave supports teachers in pursuing further education, training, or research that enhances their teaching skills. This leave may be paid or unpaid and is usually subject to approval based on the relevance of the proposed activity to the teacher's role.

SABBATICAL LEAVE

SABBATICAL LEAVE IS A LONGER-TERM LEAVE OPTION THAT ALLOWS TEACHERS TO TAKE AN EXTENDED BREAK FROM TEACHING DUTIES TO ENGAGE IN RESEARCH, STUDY, OR OTHER PROFESSIONAL GROWTH ACTIVITIES. SABBATICALS ARE OFTEN GRANTED AFTER A SPECIFIED NUMBER OF YEARS OF SERVICE AND MAY BE PARTIALLY PAID.

ELIGIBILITY AND ENTITLEMENT

HOW SHOULD A TEACHER REQUEST A LEAVE OF ABSENCE?

A TEACHER SHOULD SUBMIT A FORMAL WRITTEN REQUEST TO THEIR SCHOOL ADMINISTRATION OR HUMAN RESOURCES DEPARTMENT, DETAILING THE REASON FOR LEAVE, THE START AND END DATES, AND ANY SUPPORTING DOCUMENTATION REQUIRED.

CAN A TEACHER'S LEAVE OF ABSENCE AFFECT THEIR JOB SECURITY?

ARE THERE LEGAL PROTECTIONS FOR TEACHERS TAKING LEAVE OF ABSENCE?
