- POST-TRAUMATIC STRESS DISORDER (PTSD)
- DIFFICULTY TRUSTING AUTHORITY FIGURES
- ACADEMIC CHALLENGES AND SOCIAL WITHDRAWAL

COMMUNITY AND SCHOOL ENVIRONMENT

SUCH INCIDENTS CAN ERODE TRUST IN EDUCATIONAL INSTITUTIONS, PROMPTING COMMUNITIES TO DEMAND STRONGER SAFEGUARDS AND ACCOUNTABILITY. SCHOOLS MAY EXPERIENCE REPUTATIONAL DAMAGE AND INCREASED SCRUTINY FROM PARENTS AND REGULATORY BODIES.

PREVENTION AND EDUCATIONAL POLICIES
