GRANTS MAY BE OFFERED BY GOVERNMENT AGENCIES, PRIVATE FOUNDATIONS, NONPROFIT ORGANIZATIONS, AND CORPORATE SOCIAL RESPONSIBILITY PROGRAMS. UNLIKE LOANS, THESE GRANTS DO NOT REQUIRE REPAYMENT, MAKING THEM HIGHLY ATTRACTIVE FOR CHURCHES OPERATING ON LIMITED BUDGETS. UNDERSTANDING THE SCOPE AND PURPOSE OF TECHNOLOGY GRANTS FOR CHURCHES HELPS ORGANIZATIONS IDENTIFY SUITABLE FUNDING SOURCES ALIGNED WITH THEIR SPECIFIC TECHNOLOGICAL GOALS.

FINANCIAL ACCOUNTABILITY

CHURCHES USUALLY NEED TO PROVIDE FINANCIAL STATEMENTS, BUDGETS, AND OTHER DOCUMENTATION SHOWING SOUND FISCAL MANAGEMENT. THIS TRANSPARENCY ASSURES GRANTORS THAT FUNDS WILL BE USED RESPONSIBLY.

GEOGRAPHIC AND DEMOGRAPHIC RESTRICTIONS

Some grants target specific regions, populations, or types of churches. It is important to verify that the church meets these geographic and demographic criteria before applying.

HOW TO APPLY FOR TECHNOLOGY GRANTS
