OVERVIEW OF WISCONSIN SUBSTITUTE TEACHER LICENSE

THE WISCONSIN SUBSTITUTE TEACHER LICENSE AUTHORIZES INDIVIDUALS TO TEMPORARILY FILL IN FOR REGULAR CLASSROOM TEACHERS IN K-12 SCHOOLS THROUGHOUT WISCONSIN. THIS LICENSE ENSURES THAT SUBSTITUTE TEACHERS MEET MINIMUM STANDARDS OF EDUCATION, COMPETENCY, AND BACKGROUND CLEARANCE. IT IS ISSUED BY THE WISCONSIN DEPARTMENT OF PUBLIC INSTRUCTION AND IS REQUIRED BY LAW FOR ANYONE WISHING TO SUBSTITUTE TEACH IN PUBLIC SCHOOLS. THE LICENSE HELPS MAINTAIN EDUCATIONAL CONTINUITY AND CLASSROOM MANAGEMENT DURING TEACHER ABSENCES. IT ALSO PROVIDES A PATHWAY FOR INDIVIDUALS INTERESTED IN GAINING CLASSROOM EXPERIENCE AND PURSUING A FULL TEACHING LICENSE IN THE FUTURE.

ELIGIBILITY REQUIREMENTS

TO QUALIFY FOR A WISCONSIN SUBSTITUTE TEACHER LICENSE, APPLICANTS MUST SATISFY SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY THE STATE. THESE REQUIREMENTS ARE DESIGNED TO ENSURE THAT SUBSTITUTES POSSESS THE NECESSARY KNOWLEDGE AND PROFESSIONALISM TO MANAGE A CLASSROOM EFFECTIVELY.

EDUCATIONAL QUALIFICATIONS

APPLICANTS TYPICALLY NEED TO HAVE COMPLETED AT LEAST 60 SEMESTER CREDITS FROM AN ACCREDITED COLLEGE OR UNIVERSITY. THIS MINIMUM COLLEGE COURSEWORK REQUIREMENT DEMONSTRATES A FOUNDATIONAL UNDERSTANDING OF ACADEMIC SUBJECTS AND TEACHING PRINCIPLES. SOME SCHOOL DISTRICTS MAY REQUIRE A FULL BACHELOR'S DEGREE DEPENDING ON THEIR POLICIES.

AGE AND RESIDENCY

APPLICANTS MUST BE AT LEAST 18 YEARS OLD AND LEGALLY ELIGIBLE TO WORK IN THE UNITED STATES. WHILE WISCONSIN RESIDENCY IS NOT STRICTLY REQUIRED, HAVING A CONNECTION TO THE STATE OR LOCAL SCHOOL DISTRICT IS BENEFICIAL FOR EMPLOYMENT OPPORTUNITIES.

ADDITIONAL REQUIREMENTS

BESIDES EDUCATIONAL CREDENTIALS, CANDIDATES MUST SUBMIT TO BACKGROUND CHECKS INCLUDING FINGERPRINTING TO COMPLY WITH CHILD SAFETY LAWS. A CLEAN CRIMINAL RECORD RELATED TO CHILD ABUSE OR OTHER DISQUALIFYING OFFENSES IS MANDATORY.

APPLICATION PROCESS

APPLYING FOR A WISCONSIN SUBSTITUTE TEACHER LICENSE INVOLVES SEVERAL STEPS AIMED AT VERIFYING QUALIFICATIONS AND ENSURING COMPLIANCE WITH STATE REGULATIONS. THE PROCESS IS MANAGED THROUGH THE WISCONSIN DEPARTMENT OF PUBLIC INSTRUCTION'S ONLINE SYSTEM.

STEP-BY-STEP APPLICATION PROCEDURE

1. COMPLETE THE ONLINE APPLICATION FORM ON THE DPI WEBSITE.
2. SUBMIT OFFICIAL TRANSCRIPTS OR PROOF OF COLLEGE CREDITS.
3. UNDERGO FINGERPRINTING AND BACKGROUND CHECK AS REQUIRED.
4. PAY THE APPLICATION FEE ASSOCIATED WITH THE SUBSTITUTE LICENSE.
5. RECEIVE CONFIRMATION AND LICENSE APPROVAL, TYPICALLY WITHIN A FEW WEEKS.

APPLICATION FEES

APPLICANTS SHOULD EXPECT TO PAY A FEE FOR PROCESSING THEIR SUBSTITUTE TEACHER LICENSE APPLICATION. THE CURRENT FEE VARIES AND SHOULD BE CONFIRMED ON THE DPI'S OFFICIAL RESOURCES BEFORE SUBMISSION.

TYPES OF SUBSTITUTE TEACHER LICENSES

WISCONSIN OFFERS SEVERAL TYPES OF SUBSTITUTE TEACHING LICENSES TAILORED TO DIFFERENT LEVELS OF EDUCATION AND EXPERIENCE. UNDERSTANDING THESE CATEGORIES HELPS APPLICANTS CHOOSE THE APPROPRIATE LICENSE FOR THEIR CAREER GOALS.

SHORT-TERM SUBSTITUTE LICENSE

THIS LICENSE ALLOWS INDIVIDUALS TO SUBSTITUTE TEACH UP TO 20 CONSECUTIVE DAYS IN THE SAME CLASSROOM WITHOUT HOLDING A FULL TEACHING LICENSE. IT IS IDEAL FOR THOSE WITH SOME COLLEGE CREDITS BUT NOT YET FULLY LICENSED TEACHERS.

LONG-TERM SUBSTITUTE LICENSE

FOR SUBSTITUTES WORKING LONGER ASSIGNMENTS OR IN SPECIALIZED SUBJECTS, A LONG-TERM LICENSE IS REQUIRED. THIS LICENSE OFTEN REQUIRES A BACHELOR'S DEGREE AND ADDITIONAL QUALIFICATIONS.

EMERGENCY SUBSTITUTE LICENSE

EMERGENCY LICENSES ARE ISSUED IN CASES WHERE THERE IS AN URGENT NEED FOR SUBSTITUTES, AND THE APPLICANT MAY NOT MEET ALL STANDARD CRITERIA. THESE ARE TEMPORARY AND SUBJECT TO SPECIFIC DISTRICT APPROVAL.

BACKGROUND CHECKS AND LEGAL REQUIREMENTS

ENSURING STUDENT SAFETY IS A PARAMOUNT CONCERN IN WISCONSIN'S SUBSTITUTE TEACHER LICENSING PROCESS. ALL APPLICANTS MUST COMPLY WITH STRICT BACKGROUND CHECK POLICIES.

FINGERPRINTING AND CRIMINAL HISTORY CHECK

APPLICANTS MUST SUBMIT FINGERPRINTS TO THE WISCONSIN DEPARTMENT OF JUSTICE AND THE FBI FOR COMPREHENSIVE CRIMINAL HISTORY SCREENING. ANY RECORD OF OFFENSES RELATED TO CHILD ABUSE, NEGLECT, OR OTHER SERIOUS CRIMES TYPICALLY DISQUALIFIES A CANDIDATE.

REPORTING REQUIREMENTS

SUBSTITUTE TEACHERS ARE LEGALLY OBLIGATED TO REPORT ANY CHANGES IN THEIR CRIMINAL RECORD OR OTHER RELEVANT INFORMATION TO THE DPI PROMPTLY. FAILURE TO COMPLY MAY RESULT IN LICENSE SUSPENSION OR REVOCATION.

RENEWAL AND CONTINUING EDUCATION

THE WISCONSIN SUBSTITUTE TEACHER LICENSE IS VALID FOR A LIMITED PERIOD AND REQUIRES RENEWAL TO REMAIN ACTIVE. RENEWAL HELPS ENSURE THAT SUBSTITUTE TEACHERS MAINTAIN CURRENT KNOWLEDGE AND SKILLS.

LICENSE VALIDITY AND RENEWAL CYCLE

TYPICALLY, SUBSTITUTE LICENSES ARE VALID FOR UP TO FIVE YEARS. APPLICANTS MUST APPLY FOR RENEWAL BEFORE THE EXPIRATION DATE TO CONTINUE SUBSTITUTE TEACHING LEGALLY.

CONTINUING EDUCATION REQUIREMENTS

WHILE CONTINUING EDUCATION IS NOT ALWAYS MANDATORY FOR SUBSTITUTE LICENSES, SOME DISTRICTS ENCOURAGE OR REQUIRE PROFESSIONAL DEVELOPMENT COURSES TO IMPROVE TEACHING EFFECTIVENESS AND CLASSROOM MANAGEMENT.

TIPS FOR EFFECTIVE SUBSTITUTE TEACHING IN WISCONSIN

BEYOND OBTAINING THE WISCONSIN SUBSTITUTE TEACHER LICENSE, SUCCESS IN SUBSTITUTE TEACHING DEPENDS ON PREPARATION, PROFESSIONALISM, AND ADAPTABILITY.

- **FAMILIARIZE WITH SCHOOL POLICIES:** UNDERSTAND THE SPECIFIC RULES AND PROCEDURES OF THE SCHOOL OR DISTRICT BEFORE YOUR ASSIGNMENT.
- **PREPARE LESSON PLANS:** REVIEW AND FOLLOW LESSON PLANS LEFT BY THE REGULAR TEACHER WHENEVER AVAILABLE.
- **CLASSROOM MANAGEMENT:** ESTABLISH CLEAR EXPECTATIONS AND MAINTAIN A POSITIVE LEARNING ENVIRONMENT.
- **COMMUNICATION SKILLS:** ENGAGE WITH STUDENTS, STAFF, AND ADMINISTRATORS EFFECTIVELY TO SUPPORT LEARNING AND SCHOOL CULTURE.
- **PROFESSIONALISM:** ARRIVE ON TIME, DRESS APPROPRIATELY, AND BE READY TO HANDLE DIVERSE CLASSROOM SITUATIONS.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE BASIC REQUIREMENTS TO OBTAIN A SUBSTITUTE TEACHER LICENSE IN WISCONSIN?

TO OBTAIN A SUBSTITUTE TEACHER LICENSE IN WISCONSIN, CANDIDATES MUST HAVE AT LEAST 60 COLLEGE CREDITS FROM AN ACCREDITED INSTITUTION AND COMPLETE THE APPLICATION PROCESS THROUGH THE WISCONSIN DEPARTMENT OF PUBLIC INSTRUCTION (DPI). BACKGROUND CHECKS ARE ALSO REQUIRED.

HOW LONG IS A WISCONSIN SUBSTITUTE TEACHER LICENSE VALID?

A WISCONSIN SUBSTITUTE TEACHER LICENSE IS TYPICALLY VALID FOR THREE YEARS. AFTER THIS PERIOD, THE LICENSE MUST BE RENEWED FOLLOWING THE DPI'S RENEWAL GUIDELINES.

CAN ANYONE WITH A BACHELOR'S DEGREE BECOME A SUBSTITUTE TEACHER IN WISCONSIN?

YES, INDIVIDUALS WITH A BACHELOR'S DEGREE FROM AN ACCREDITED INSTITUTION ARE ELIGIBLE TO APPLY FOR A SUBSTITUTE TEACHER LICENSE IN WISCONSIN, PROVIDED THEY MEET OTHER REQUIREMENTS SUCH AS BACKGROUND CHECKS AND APPLICATION PROCEDURES.

ARE THERE DIFFERENT TYPES OF SUBSTITUTE TEACHER LICENSES IN WISCONSIN?

WISCONSIN PRIMARILY ISSUES ONE TYPE OF SUBSTITUTE TEACHER LICENSE, WHICH ALLOWS INDIVIDUALS TO WORK AS SUBSTITUTES IN K-12 PUBLIC SCHOOLS. HOWEVER, SOME DISTRICTS MAY HAVE ADDITIONAL REQUIREMENTS OR ENDORSEMENTS.

HOW DO I APPLY FOR A SUBSTITUTE TEACHER LICENSE IN WISCONSIN?

TO APPLY, CANDIDATES MUST SUBMIT AN APPLICATION THROUGH THE WISCONSIN DPI WEBSITE, PROVIDE OFFICIAL TRANSCRIPTS SHOWING AT LEAST 60 COLLEGE CREDITS, COMPLETE A BACKGROUND CHECK, AND PAY THE APPLICABLE FEES.

IS THERE ANY REQUIRED TRAINING FOR SUBSTITUTE TEACHERS IN WISCONSIN?

WHILE WISCONSIN DOES NOT MANDATE SPECIFIC TRAINING BEFORE OBTAINING A SUBSTITUTE LICENSE, SOME SCHOOL DISTRICTS MAY REQUIRE ORIENTATION OR TRAINING SESSIONS BEFORE ALLOWING SUBSTITUTES TO WORK IN THEIR SCHOOLS.

CAN SUBSTITUTE TEACHERS IN WISCONSIN WORK FULL-TIME?

SUBSTITUTE TEACHING IS GENERALLY CONSIDERED A PART-TIME OR TEMPORARY ROLE. HOWEVER, SOME SUBSTITUTES MAY WORK FULL-TIME IF THEY ARE ASSIGNED LONG-TERM POSITIONS OR IF DISTRICTS HAVE ONGOING SUBSTITUTE NEEDS.

WHAT IS THE COST OF OBTAINING A SUBSTITUTE TEACHER LICENSE IN WISCONSIN?

THE APPLICATION FEE FOR A WISCONSIN SUBSTITUTE TEACHER LICENSE TYPICALLY RANGES AROUND \$50 TO \$100, BUT CANDIDATES SHOULD CHECK THE WISCONSIN DPI WEBSITE FOR THE MOST CURRENT FEE SCHEDULE.

DO SUBSTITUTE TEACHERS IN WISCONSIN NEED TO RENEW THEIR LICENSE?

YES, SUBSTITUTE TEACHER LICENSES IN WISCONSIN MUST BE RENEWED EVERY THREE YEARS. RENEWAL REQUIRES SUBMITTING AN APPLICATION AND PAYING THE RENEWAL FEE TO THE WISCONSIN DPI.
