BACKGROUND AND CONTEXT OF WITTGENSTEIN PHILOSOPHICAL INVESTIGATIONS

WITTGENSTEIN **PHILOSOPHICAL INVESTIGATIONS** WAS PUBLISHED POSTHUMOUSLY IN 1953, MARKING A SIGNIFICANT DEPARTURE FROM HIS EARLIER WORK, THE **TRACTATUS LOGICO-PHILOSOPHICUS**. MEANING AS USE

CENTRAL TO WITTGENSTEIN'S LATER PHILOSOPHY IS THE THESIS THAT MEANING IS DETERMINED BY THE USE OF WORDS IN PARTICULAR CONTEXTS. THIS PRAGMATIC VIEW OPPOSES REPRESENTATIONALIST THEORIES OF MEANING AND HIGHLIGHTS THE FUNCTIONAL ROLE OF LANGUAGE IN COMMUNICATION AND SOCIAL INTERACTION.

LANGUAGE GAMES AND FORMS OF LIFE

- LANGUAGE GAMES VARY ACROSS DIFFERENT ACTIVITIES LIKE QUESTIONING, COMMANDING, DESCRIBING, OR STORYTELLING.
- FORMS OF LIFE REFLECT THE SOCIAL CONDITIONS AND PRACTICES THAT SUSTAIN LANGUAGE USE.
- UNDERSTANDING LANGUAGE REQUIRES ATTENTION TO BOTH THE SPECIFIC LANGUAGE GAME AND THE FORM OF LIFE IT BELONGS TO.

MEANING, USE, AND RULE-FOLLOWING

THE EXPLORATION OF MEANING AND RULE-FOLLOWING IS CENTRAL TO WITTGENSTEIN'S CRITIQUE OF TRADITIONAL SEMANTICS AND PHILOSOPHY OF MIND. HIS INSIGHTS CHALLENGE THE NOTION OF FIXED MEANINGS AND HIGHLIGHT THE DYNAMIC NATURE OF LINGUISTIC PRACTICES.

RULE-FOLLOWING PARADOX

WITTGENSTEIN POSES THE RULE-FOLLOWING PARADOX, QUESTIONING HOW INDIVIDUALS CAN FOLLOW RULES PRIVATELY AND CONSISTENTLY. HE ARGUES THAT RULE-FOLLOWING IS GROUNDED IN COMMUNAL AGREEMENT AND PRACTICE RATHER THAN INDIVIDUAL MENTAL INTERPRETATION, WHICH PREVENTS THE POSSIBILITY OF PURELY PRIVATE UNDERSTANDING.

IMPLICATIONS FOR UNDERSTANDING MEANING

THIS PERSPECTIVE LEADS TO THE UNDERSTANDING THAT MEANING IS NOT A MENTAL ENTITY ATTACHED TO WORDS BUT A PATTERN OF USE GOVERNED BY SHARED RULES. MEANING EMERGES FROM PUBLIC CRITERIA AND NORMATIVE FRAMEWORKS ESTABLISHED WITHIN LANGUAGE COMMUNITIES.

PHILOSOPHICAL METHOD AND STYLE

'LANGUAGE GAMES' ILLUSTRATE THAT LANGUAGE FUNCTIONS THROUGH DIVERSE ACTIVITIES GOVERNED BY RULES WITHIN SPECIFIC CONTEXTS, HIGHLIGHTING THAT MEANING IS DETERMINED BY USE RATHER THAN BY AN ABSTRACT, UNIFORM STRUCTURE.
