It is my prayer that we will all learn from the process, and be filled with the knowledge of his will through all the wisdom and understanding that the Spirit gives, so that [we] may live a life worthy of the Lord and please him in every way: bearing fruit in every good work, growing in the knowledge of God (Colossians 1:9-10).
