Since women's concerns are varied, numerous, and interdisciplinary in nature, the SWGU officially directed it efforts towards the promotion of women's causes while unofficially targeting the whole spectrum of governmental institutions and non-governmental organisations (NGOs), rather than limiting its efforts by trying to establish a ministry for women's affairs.
