MONARCHY AND AUTOCRACY

LIBERTARIANISM PROMOTES INDIVIDUAL FREEDOM AND MINIMAL GOVERNMENT INTERFERENCE. NATIONALISM CENTERS ON PRIORITIZING THE INTERESTS AND CULTURE OF ONE'S NATION, OFTEN EMPHASIZING SOVEREIGNTY AND PATRIOTISM.

COMMITTEES ARE SMALLER GROUPS WITHIN LEGISLATIVE BODIES TASKED WITH REVIEWING BILLS AND POLICIES. HEARINGS ARE FORMAL MEETINGS WHERE EVIDENCE IS PRESENTED AND EXPERTS OR WITNESSES MAY TESTIFY REGARDING PROPOSED LEGISLATION.

LOBBYING AND ADVOCACY

LOBBYING INVOLVES EFFORTS BY INDIVIDUALS OR GROUPS TO INFLUENCE LEGISLATORS AND GOVERNMENT OFFICIALS. ADVOCACY IS THE BROADER PRACTICE OF PROMOTING CERTAIN POLICIES OR CAUSES WITHIN THE POLITICAL ARENA.

In Part II, this is contrasted with the way democratic states attract investment through institutional protections and public benefits. In this way, the author uncovers that authoritarian and democratic states achieve investor confidence through "alternate paths to predictability", one based on eliminating opposition through political consolidation and the other based on impartial rules and legal protections designed to constrain the excesses of political competition. The theory's central premise, that the concentration of economic influence with fewer "economic elites" is corrosive to political competition and institutional quality, carries huge significance for the study of both authoritarian and democratic governance quality.

People's experiences with service providers matter. Far from being de-politicizing, negative experiences can be empowering, stimulating greater political interest and more political activity. In contrast to the findings of some American studies, there is no evidence that these encounters leave claimants in Canada with the sense that they are neither legitimate nor effective actors in the public sphere. Rather than discouraging participation in politics, being a

recipient of means-tested benefits likewise seems to be politically mobilizing. Based on extensive survey data, *Take a Number* casts new light on the problem of non-take-up of social benefits. Elisabeth Gidengil reveals that those who are most likely to benefit are often unaware of government programs. The more demanding and intrusive the claiming process, the more likely claimants are to find it difficult to access the program. These experiences with government programs prove to have larger implications for users' confidence in institutions and their satisfaction with democracy.
