STATEMENTS THAT NORMALIZE EMOTIONAL EXPERIENCES OR ACKNOWLEDGE CLIENT COURAGE SUPPORT PSYCHOLOGICAL COMFORT. THIS CAN LEAD TO QUICKER RAPPORT DEVELOPMENT AND A MORE OPEN THERAPEUTIC PROCESS.

#### ENCOURAGING CLIENT EMPOWERMENT

Pre-therapy language that promotes autonomy and choice empowers clients to take active roles in their healing. Phrases that invite client input and collaboration foster a sense of control and respect. This empowerment is associated with improved therapy engagement and outcomes.
